A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(3) THE PURCHASE OF A 12 YARD DUMP TRUCK FROM LOU BACHRODT FREIGHTLINER IN AN AMOUNT NOT TO EXCEED \$112,610.00 THROUGH THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES CONTRACT FOR CAB & CHASSIS TRUCKS AND HEAVY EQUIPMENT #FSA18-VEH16.0; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a 12 Yard Dump Truck, in an amount not to exceed \$112,610.00, from Lou Bachrodt Freightliner is hereby authorized, through the Florida Sheriff's Association and Florida Association of Counties Contract for Cab & Chassis Trucks #FSA18-VEH16.0, pursuant to Section 2-797(3) of the Code of Ordinances.

Section 2: That adequate funds for this purchase are budgeted in FY 2020 Internal Improvements/Sidewalks/Machinery & Equipment Account No. 102-4104-541-6400. Any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
