A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, August 2, 2011.

Mayor Craig Cates called the meeting to order at 6:08 p.m.

City Manager's Report

City Manager Scholl briefed the Commission on Tropical Storm Emily. Mr. Scholl stated the Budget Workshops had been presented the previous week and the tentative milage rate was set at 2.8627 and would be formally adopted by the Commission in September. Mr. Scholl stated the newspaper article in Sunday's paper was misleading regarding the solid waste contract with Waste Management.

Commissioner Johnston asked for a School District update on the 5% capacity issue. Mr. Scholl has spoken with the School Superintendent. A consultant had been hired to determine the student station numbers for Horace O'Bryant School. The City and School Administration were scheduled to meet again later in the month. They would then move forward with the Interlocal Agreement and the process that needed to be done to resolve the problem.
