A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA), AUTHORIZING A FUNDING "LETTER OF COMMITMENT" FROM THE CITY OF KEY WEST IN THE AMOUNT OF UP TO \$250,000.00 IN SUPPORT OF PRESERVATION OF THE SCHOONER WESTERN UNION, CONTINGENT UPON THE AWARD/RECEIPT OF MATCHING FUNDS (2:1 RATIO OF STATE FUNDING TO LOCAL FUNDING) FROM THE STATE OF FLORIDA HISTORIC PRESERVATION GRANT PROGRAM; PROVIDED THAT THE LETTER OF COMMITMENT IS ALSO CONTINGENT UPON THE EXECUTION OF AN AGREEMENT TO ENSURE THAT THE SCHOONER WESTERN UNION WILL REMAIN AT THE KEY WEST HISTORIC SEAPORT; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Schooner Western Union was submitted to the National Register of Historic Places on May 16, 1984; and

in Resolution No. 97-301, the City of Key West WHEREAS, proclaimed the Schooner Western Union the Official Flagship of the City of Key West, and in the Florida State House Rotunda it is listed as the State Flagship of Florida; and

WHEREAS, the Schooner Western Union remains an integral piece of the history of Key West and the Historic Seaport at Key West Bight; and

WHEREAS, the Schooner Western Union requires substantial restoration and upgrades to remain seaworthy, and continue its role as a unique example of living history to educate residents and visitors about the significant role of Key West, and the State of Florida, within maritime history; and

WHEREAS, the Schooner Western Union Preservation Society (SWUPS), a 501(c)3 non-profit organization, is charged with preserving the Schooner Western Union, and has identified a State Historic Preservation grant funding program, which requires a funding match of up to \$250,000.00, towards a restoration project with a total value of up to \$750,000.00; and

WHEREAS, at its meeting of June 10, 2015, the Key West Bight Management District Board considered SWUPS request for a funding Letter of Commitment from the City, in support of their grant application; and

WHEREAS, a Letter of Commitment would enable SWUPS to meet the grant deadline of June 30, 2015 and help to preserve the Schooner Western Union for generations to come; and

WHEREAS, there are sufficient funds in the Key West Bight unrestricted reserves to account for this cost.

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That a Letter of Commitment, for the amount of up to \$250,000.00, to the Schooner Western Union Preservation Society and Museum is hereby authorized.

Section 2: That any financial commitment set forth in the Letter of Commitment authorized herein on behalf of the Key West Historic Seaport/City of Key West, is contingent upon the award of a State of Florida Historic Preservation Grant for restoration of the Schooner Western Union. City/CRA funds will be used specifically to match the State grant funds in a 50% ratio, up to a total of \$250,000.00.

Section 3: That SWUPS shall agree to execute an agreement to guarantee that the vessel will remain at the Key West Historic Seaport.

Section 4: That no funds shall be expended as a result of this Letter of Commitment without further Resolution of the City Commission.

Section 5: That necessary budget transfers are authorized consistent with this resolution.

Section 6: That the City Manager is authorized to execute a Letter of Commitment for the amount of up to \$250,000.00, as required for grant application purposes for the State of Florida Historic Preservation Grant documents, upon the advice and consent of the City Attorney.

Section 7: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.

SUBJECT: Schooner Western Union Funding Request

On the June 10, 2015 Key West Bight Board agenda is an item sponsored by Board Member Harry Bowman that is requesting a letter of commitment in the amount of \$250,000 to be used as matching funds for a \$500,000 State of Florida, Historic Preservation grant for restoration of the Schooner Western Union. The request was submitted by the Schooner Western Union Preservation Society and Museum.

Staff, in reviewing the request, has several comments:

 This is not a budgeted item so a budget amendment/transfer from reserves would be required. There is sufficient unrestricted reserve dollars for this request.

If the funding is approved there needs to be some guarantee that the vessel will remain at the Key West Historic Seaport.

3. What are the long term plans for maintaining and successfully operating the ship after this major overhaul?

Staff believes that if the restrictions are put in place to guarantee that the vessel remains at the Historic Seaport and is operated successful, then a commitment of the financial resources to restore the vessel is an appropriate use of Key West Historic Seaport dollars.

#### CKW/CRA Executive Summary Schooner Western Union /KWBB Funds Request

- a. As the City of Key West and State of Florida Flagship, an important distinction of the schooner Western Union is being the last of the iconic tall coasting schooners constructed and launched in Key West.
- b. The schooner is the last remaining representation of the Historic Key West Bight maritime heritage and is the "Centerpiece of the Key West Bight."
- c. As a state treasure, the schooner Western Union name is displayed in honor -- high on the Florida state house rotunda wall listed as the State Flagship.
- d. The schooner Western Union represents to Key West what the USS Constitution "Old Ironsides" represents to the port of Boston and the Statue of Liberty to the port of New York.
- e. Such Flagship designations make the schooner Western Union the symbolic property of the citizens of Key West & Florida Keys and the State of Florida.
- f. SWUPS, a 501-c3 not-for-profit, FL Corporation is charged with preserving the SOF historic Flagship, the schooner Western Union
- g. SWUPS has no paid staff and is an all-volunteer organization (outside of a Capt. and crew employed during passenger sailing operations.)
- h. SWUPS board of directors believes that completing the restoration of the schooner Western Union falls in tandem with the mission of the Key West Bight Board to preserve and enhance the quality of the Historic Seaport.
- The request is for \$250,000 in the form of a funding Letter of Commitment from the Key West Bight Management District/City of Key West.

- j. The application for the \$500,000 (2 to 1) matching funds from the State of Florida Historic Preservation Grant Program must be completed in full and received in e-form no later than 5:00 PM, <u>June 30, 2015</u> in order to qualify for the grant.
- k. SWUPS will support codicils with the \$250,000 funding that require the schooner Western Union remain home ported in Key West and operate for the benefit of Key West residents and visitors.
- The schooner Western Union will only depart Key West for maintenance or brief participation in historic events.
- m. The restoration will be performed in accordance of the guidelines outlined in the State of Florida – Department of State, Division of Historical Resources (DHR) and will be supervised by the Historic Preservation Grants Department.
- n. The completion of this second phase of a two-part (nearly) \$2 million restoration of the schooner Western Union represents the first major renovation of the 76-yr. old historic vessel since the schooner's construction and launch from Key West in April 1939.
- o. SWUPS passenger sailing operations have demonstrated since 2011 that the schooner Western Union can generate enough revenue to support sailing operations plus generate a 10% excess per year that will be used for the vessels biennial haul outs.
- p. Licensed shipwright estimates and quotes from MarPro Boatyard, Tarpon Springs, reveal that \$750,000 is adequate to cover the renovation expense including tracking expenses and administrative expenses.
- q. A more detail estimate is expected prior to the KWBB meeting on Wed., 10 June

Dear Mayor & City Commissioners,

Thank you for the opportunity to tell you about the schooner Western Union, the Flagship of the State of Florida and the City of Key West.

The Schooner Western Union Preservation Society & Museum (SWUPS) is a Florida 501(c) (3) not-for profit-organization FEI # 20-5958968.

SWUPS is charged with preserving and operating the State of Florida and City of Key West Flagship. We are an all-volunteer organization with no paid staff (outside of a Capt. and crew during sailing operations.)

Launched in April 1939, the 76-yr. old schooner was the last of the iconic coasting schooners built and launched in Key West. The schooner maintained the Western Union Telegraph Company undersea cables that linked Florida's coastal cities to the Caribbean island nations', Central & South America and the Gulf states. In doing so, the schooner greatly contributed to Florida's economic growth.

In 2012, the Florida House and Senate voted unanimously to designate the historic schooner the official Flagship of the State of Florida. The Governor signed the legislation and on July 1, 2012 the schooner Western Union became a state treasure. The schooner is now listed high on the state Capitol rotunda wall as the State Flagship.

The City of Key West passed a resolution in 1997 naming the schooner Western Union as the Flagship of the City of Key West.

In 1984, The U.S. Department of Interior placed the schooner on the "National Register of Historic Places".

Historic Tours of America donated the Western Union to SWUPS in 2007, debt free. A fund raising project began to perform a first time major restoration of the 70-yr. old wooden schooner.

The Monroe County Tourist Development Council provided a \$405,000 award and the Historic Florida Keys Foundation a \$300,000 grant. A number of grass roots Monroe county residents and businesses contributed \$239,949 in (tax declared) donations ranging from \$1 to \$25,000.

In 2009 a temporary shipyard was constructed at the Truman Waterfront and the first phase of a two-part major restoration project of the schooner was underway using professional shipwrights whose experience included work on the USS Constitution.

Florida's Historic Sailing Maritime Museum

The first phase of the restoration was a \$1 million project. The second and final phase of the restoration was to be another \$1 million.

Passing a United States Coast Guard (USCG) certification process, the schooner was relaunched into service April 2011. A launching ceremony was held in the Key West Bight and then a fleet of Key West vessels with water cannons sailed with the schooner out of the harbor.

The (temporary) SWU/USCG passenger sailing certification expired July 2013 and the secondphase of the major restoration must be completed before the schooner can resume service. More importantly, so the schooner can be saved for future Key West generations and visitors to enjoy.

An established well-known shipyard in Tarpon Springs was purchased by MarPro Investors of St. Petersburg, FL who has funded renovating and expanding the yard's capabilities to work on wooden ships larger than the Western Union. MarPro desires to be the yard to restore the State of Florida & Key West Flagship and has offered generous terms and pricing within a \$750,000 budget

SWUPS had the senior MarPro, Tarpon Springs Shipwright come to Key West for two-days in the past month to access the schooner. The schooner Western Union's respected sea Captain of over 20-yrs., Lenn Verreau, has sailed the schooner to the Tarpon Yard for repairs over the years and highly recommends the facility.

The Captain will be in the Tarpon Boat Yard for the restoration process and will be SWUPS on-site point of contact for the MarPro shipwrights.

The Historic Grant Program administered by the Florida Department of State (DOS) will provide a two to one (2 to 1) match of restoration funds up to a \$500,000 grant total.

The FL DOS advised a funding Letter of Commitment from the Key West Bight Board/City of Key West will serve as SWUPS match to qualify for the (2 to 1) Historic Preservation Grant Award

A Letter of Commitment in the amount of two-hundred and fifty thousand dollars (\$250,000) from the KWBB/CKW will enable SWUPS to be applicable to receive a five hundred thousand dollar grant (\$500,000) from the state of Florida.

SWUPS has been in communication during the past two years with the SOF Grant Program and two-months ago the program administrator reached out and encouraged SWUPS to apply for funding. The Historic Grant Application must be received in Tallahassee by June 30, 2015.

The SOF \$500,000 grant and the matching \$250,000 KWBB/CKW funds are administrated under SOF strict spending management protocol that include a planned work program, inspections and documentation controls similar to that of the Monroe County TDC award that SWUPS adhered to in the first phase of the two-part renovation.

SWUPS \$405,000 TDC Award was processed during the first renovation through the county offices without issue and was properly tracked and controlled within the strict county financial award protocols and guidelines.

All work is required to be inspected and approved by the United States Coast Guard.

SWUPS appreciates this opportunity to partner with the KWBB/CKW to complete the restoration of the Centerpiece of the Historic Bight; our City & State Flagship, the Western Union.


