A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A WORK ORDER UNDER THE CITY'S ENVIRONMENTAL ENGINEERING SERVICES CONTRACT WITH TETRA TECH, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$40,000.00 FOR REST BEACH STABILIZATION REDESIGN AND BIDDING SERVICES, INCLUDING AN UPDATED TOPOGRAPHICAL SURVEY, FOLLOWING HURRICANE IRMA; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS/AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-359, the City Commission approved a three-year Environmental Engineering Services contract with Tetra Tech, Inc.; and

WHEREAS, in Resolution No. 16-066 the City Commission approved a proposal from Tetra Tech to provide Planning, Engineering, Design and Permitting to stabilize the sloped shoreline along Rest Beach; and

WHEREAS, in Resolution 17-170 the City Commission approved a work order for additional design services along with CEI services for the project, incorporating additional requirements from the Florida Department of Environmental Protection (FDEP); and

WHEREAS, Hurricane Irma significantly altered the topography of Rest Beach, and accordingly, additional

engineering services, including a new/updated survey, associated revisions to construction documents, and rebidding of the redesigned Rest Beach project is necessary; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a work order for Rest Beach Stabilization Redesign and bidding services, including an updated topographical survey, to address Hurricane Irma impacts, under the City's Environmental Engineering Services Contract with Tetra Tech, Inc. is hereby approved in an amount not to exceed \$40,000.00.

Section 2: This project will be funded from account No. 001-191-0519-6500, Project No. HU17010301, and any necessary budget amendments/transfers are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
