## **CITY COMMISSION MEETING**

## **TUESDAY, MARCH 1, 2011**

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, March 1, 2011.

Mayor Craig Cates called the meeting to order at 6:04 p.m.

Mayor Cates announced that former Mayor Dennis Wardlow was in the audience.

City Attorney's Report

City Attorney Smith reported on the progress of negotiations with Florida Keys Assisted Care Coalition and Family Pride.

City Manager's Report

City Manager Scholl reported on the Glynn Archer School negotiations process. Meetings would continue to discuss shared use and equity division of property for actual shared ownership and shared responsibility.

Mr. Scholl reported they had received an Army Corp of Engineers permit for Smathers Beach Renourishment.

Mr. Scholl stated they had agreed upon two appraisal types for the Pier House property, fair market value for highest and best use and fair market value as it would be to the Pier House because of the position they have on the property.

Mr. Scholl reported he had several engagements with the commanding officer and executive officer of the pre-commissioning ship U. S. S. Spruance DDG111 regarding the commission of this ship on October 1, 2011 which will take place in Key West. He stated they expected 5,000 guests in town for the commissioning. He said meetings will continue each month and increase as the event drawns near.

Mr. Scholl reminded the Commission of the special LRA meeting on Thursday at 5:00 p.m.

Commissioner Johnston asked about an architect of record for Glynn Archer. Mr. Scholl stated Mr. Pope's proposal was for 100% restoration and Mr. Bender's proposal was not as extensive. Mr.

Finigan stated there would be an RFQ at a later date for an architect of record for the design of Glynn Archer.

Commission Johnston asked for an update on the consultant to review the employee pension plan.

Commissioner Weekley asked for a presentation at the next meeting from Mosquito Control.

Mr. Weekley also requested an update on code violations at 720 Southard Street.

Commissioner Gibson asked the City Attorney about the towing ordinance. Mr. Smith said a revised version would be drafted at the Commission's request. Commissioner Rossi stated he had spoken with the City Attorney about the towing ordinance.

Commissioner Lopez stated Mosquito Control and the Health Department would be giving a presentation at next meeting regarding Dengue.
