The Coastal Christmas Lighting Company was founded in 2018 following a move from metro-Atlanta, GA to a barrier island in South Georgia. Upon settling in my wife's childhood neighborhood, we observed a lack of Christmas lighting as the holiday season approached. Recognizing an opportunity, I established my lighting business, which has since flourished. Over the past six years, our neighborhood has transformed into the most festive on the island, drawing the Christmas Trolley twice daily. Notably, my residential displays garnered the attention of the county commission, leading to a collaborative effort with commissioners and planners to develop a comprehensive local Christmas display master plan with long term goals to lighting more of our historic district each year.

My affinity for Christmas lights traces back to my childhood, where I worked at our family's Christmas tree lot in Marietta, GA. With a rich history in the Christmas tree industry, we have supplied Christmas trees to the Governor's Mansion in Atlanta for numerous years.

As a multi-generational family business, Christmas holds a special significance beyond mere work – it offers an opportunity to spread holiday joy. With four team leads overseeing large-scale projects and seasonal technicians handling installations, removals, and maintenance, we undertake projects throughout Georgia and Florida, specializing in coastal regions.

Our company's endeavors have been highlighted in the Brunswick News, showcasing personal narratives and installations such as the impressive 26-foot tall live tree at the oceanfront plaza in Saint Simons Island's Historic Pier Village and my own personal story of how Christmas became my biggest passion.

TO ENSURE THE SAFETY OF OUR TECHNICIANS WE DEFINE INCLEMENT WEATHER AS:
For a holiday lighting company, inclement weather conditions that may hinder work, repairs, and maintenance could include:

1. **Heavy Rain or Storms:** Excessive rain or thunderstorms can pose safety hazards for crew members working with electrical equipment and climbing ladders. Wet conditions may also affect the functionality of lighting fixtures and increase the risk of electrical hazards.
2. **High Winds:** Strong winds can make it unsafe for crew members to work at heights, such as when installing or repairing lighting displays. Windy conditions can also cause decorations to sway or become damaged, requiring additional maintenance.
3. **Snow or Ice:** Snow accumulation or icy surfaces can create slippery conditions, making it unsafe for crew members to work outdoors, especially when using ladders or working on roofs. Snow and ice can also weigh down decorations and potentially damage them if not addressed promptly.
4. **Extreme Cold:** Extremely cold temperatures can pose health risks to crew members, especially if they are exposed to the elements for extended periods.
