**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING THE FINAL DESIGN CRITERIA FOR THE KEY WEST WELCOME AND THANK YOU FOR VISITING SIGNS, LOCATED AT THE INTERSECTION OF US-1, NORTH ROOSEVELT BLVD. AND SOUTH ROOSEVELT BLVD ALSO KNOWN AS THE "TRIANGLE"; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY BUDGET TRANSFERS OR AMENDMENTS, UPON CONSENT OF THE CITY ATTORNEY'S OFFICE; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, The City of Key West desires to welcome the public through the design, installation, and maintenance of "Welcome" and "Thank You for Visiting" signs, designed in accordance with the City's adopted brand standards, to be located at the intersection of US-1, North Roosevelt Blvd. and South Roosevelt Blvd also known as the "triangle" on Florida Department of Transportation ("FDOT") owned right-of-way; and

WHEREAS, staff is requesting directions from City Commission on the following design elements:

1. Design-Informal (option 1) or formal (option 2 or 3)
2. Granite color- Kershaw Granite or George Blue Granite
3. Final Verbiage:
  - a. Entrance Sign: "Welcome to the City of Key West" or "Welcome to Key West"
  - b. Exit Sign: "Thank You for Visting the City of Key West" or "Thank You for Visting Key West or "Come Back Soon City of Key West" or "Come Back Soon Key West;" and

WHEREAS, both signs will feature the City seal; and  
WHEREAS, once the final design criteria is approved, staff  
will seek preliminary drawings and quotes from vendors and will  
present those to City Commission at a future meeting for approval  
prior to sign production;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE  
CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Visiting" signs:
