**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST (CITY) APPROVING A WORK ORDER UNDER THE CITY'S GENERAL UTILITIES AND INFRASTRUCTURE SERVICES CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$93,541.11 FOR THE EMERGENCY ROADWAY REPAIR TO REYNOLDS STREET AT THE INTERSECTION OF CASA MARINA STREET; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, in Resolution 21-125, the City Commission awarded ITB #21-007 for General Utilities and Infrastructure Services Contract, to provide infrastructure services within the City to Charley Toppino & Sons, Inc.; and

WHEREAS, City staff recommends approval of a Work Order for emergency roadway repairs to Reynolds Street at the intersection of Casa Marina Street; and

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA, AS FOLLOWS:

Section 1: That the attached Work Order in the amount of \$93,541.11 under the contract awarded to Charley Toppino and Sons, Inc. (ITB #21-007) in Resolution 21-125, for emergency roadway repairs to Reynolds Street at the intersection of Casa Marina Street is hereby approved.

Section 2: That funds for the Task Order are allocated in account #102-4102-541-6300 (Internal Improvements/Gas Tax), Project #II41022401.

Section 3: That the City Manager is authorized to execute documents related to this Work Order, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
