A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RANKING RESPONDENTS RFP 007-11 FOR TO KEY WEST HISTORIC RESOURCE SURVEY 2011; AUTHORIZING STAFF TO NEGOTIATE A CONTRACT ACCORDANCE WITH THE ACCEPTED PROPOSALS WITH THE TOP RANKED FIRM AND EACH FIRM THEREAFTER AS NECESSARY UNTIL AN ACCEPTABLE CONTRACT IS AGREED UPON; AUTHORIZING THE CITY MANAGER, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY TO EXECUTE THE RESULTING CONTRACT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Evaluation Committee recommended acceptance of the ranking, and preparation and execution of a contract in accordance with the RFP.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby ranks the top three firms based upon the proposals submitted as:

- 2. _GAI Consultants, Inc._____
- 3. _New South Associates, Inc.____

Section 2: That City staff is authorized to negotiate a contract in accordance with the proposals accepted, starting with the top-ranked firm and, if necessary, with each of the ranked firms thereafter until an acceptable agreement is reached.

Section 3: That the City Manager, upon the advice and consent of the City Attorney, is authorized to execute the contract.
