A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A WORK ORDER UNDER THE CITY'S PAVEMENT MARKINGS, STRIPING & ROADWAY SIGNAGE CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$105,725.10 FOR PAVEMENT MARKING INCLUSIVE OF ALL ROW AND PERMITTING FEES FOR STREETS REFERENCED IN THE ATTACHED WORK ORDER; AUTHORIZING BUDGET ADJUSTMENTS IF NECESSARY; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 20-095, the City Commission awarded ITB 20-007 for Pavement Marking, Striping and Roadway Signage to Charley Toppino & Sons, Inc.; and

WHEREAS, City staff recommends approval of a Work Order for pavement marking on streets including Varela Street (United to Truman), Thomas Street (Catherine to Southard), Angela Street (Emma to Thomas Street), Reynolds Street (Seminole to Atlantic), Seminole Street (Alberta to Reynolds) and South Roosevelt at Smathers Beach, in accordance with FDOT standards and Key West Code of Ordinances, Chapter 70, Article IV, Division 5 Residential

Parking Permit Program and Resolution 18-294 setting forth the percentage of Residential Parking Spaces per block; and;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Work Order under the City's Pavement Marking, Striping and Roadway Signage Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$105,725.10, for pavement marking, striping and roadway signage on streets listed under the attached Work Order is hereby approved.

Section 2: That funding is allocated for FY 20 in account 102-4102-541-4600 (Project II41022003), and any necessary budget adjustments are hereby approved.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
