Section 2: That adequate funds for this purchase are budgeted in FY 23-24 in the IT Department operating supplies and machinery/equipment budget: 001-1303-513-6400 (Desktop and laptop replacement budget line items). Any necessary budget transfers or adjustments are hereby authorized.
