A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING BOURBON STREET PUB, INC. TO CONDUCT A "NEW YEAR'S EVE SHOE DROP NEW QUEEN CONTEST" AT 724 DUVAL STREET ON SATURDAY, OCTOBER 4, 2025, FROM 7:00 P.M. TO 11:00 P.M (SET-UP AT 5:00 P.M.); PURSUANT TO THE TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES, CITY OF KEY WEST, FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Bourbon Street Pub, Inc. has applied to the City for a Special Event Permit for their event "New Year's Eve Shoe Drop New Queen Contest" at 724 Duval Street during the hours of 7:00 p.m. to 11:00 p.m. on Saturday, October 4, 2025 (set-up at 5:00 p.m.); and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily

recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City.

SECTION 3. That Bourbon Street Pub, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place as herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. Section 6-86 of the Key West Code of Ordinances requires a Special Event permit to depart from the requirements of the City's Noise Control Ordinance.

Section 5. There will be live, amplified music played and singing during the event.

SECTION 6. That Bourbon Street Pub, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 7. That Bourbon Street Pub, Inc. acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 8. That this resolution shall go into effect
immediately upon its passage and adoption and authentication by the
signatures of the presiding officer and Clerk of the Commission.
