A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE OF TWO (2) AUTOMATIC CONTROL CHECK VALVES FROM FLUID CONTROL SPECIALTIES, INC. IN AN AMOUNT NOT TO EXCEED \$103,796.00 ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) AND 2-844(a) OF THE CODE OF ORDINANCES FOR USE AT THE WASTEWATER TREATMENT PLANT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, the PE pumps and check valves in service at the Wastewater Treatment Plant need replacement after 25 years in service, and use of a different brand would necessitate cost prohibitive alterations to the entire system; and

WHEREAS, Key West Code of Ordinances section 2-844(a) further provides "Since use of a brand name specification is restrictive of product competition, it may be used only when the purchasing agent makes a written determination that only the identified brand name item will satisfy the city's needs."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the sole source purchase of two (2) Automatic Control Check Valves from Fluid Control Specialties, Inc. in an amount not to exceed \$103,796.00 is hereby approved, pursuant to Section 2-797(1) and 2-844(a) of the code of ordinances, for use at the Wastewater Treatment Plant.

Section 2: That funding in the amount of \$80,000.00 is budgeted in FY 18 for purchase of one PE Pump Check Valve. The transfer of additional funds as necessary for the purchase of two pump/automatic control check valves, from the sewer repair and maintenance cost center, is authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
