#### **Experience with Appropriations Advocacy**

Venable has a well-positioned, successful appropriations practice that can be of great benefit to the City. Our experience includes performing appropriations work for the Tulsa Airport Authority, Tulsa, OK, and for the Napa Valley Vine Trail Coalition, among other engagements.

Mr. Gill, proposed as project manager if Venable is selected for this engagement, has particular skills in securing appropriations and federal grant funding on behalf of clients. Representative examples of Mr. Gill's and Venable's experience are presented below.

Miami-Dade Community College (MDCC): Mr. Gill assisted M-DCC on numerous legislative and regulatory issues related to its educational and community service programs. In close cooperation with community groups involved in the effort to "rebuild" Miami in the wake of Hurricane Andrew, M-DCC proposed to relocate the Aviation Training Program to Homestead Air Force Base. Mr. Gill's efforts resulted in \$10.5 million in funding for M-DCC's initiative, through Defense Appropriations. Worked successfully with M-DCC to maintain the student financial aid eligibility of legal resident aliens, which was proposed for elimination in the Welfare and Immigration Reform Act. Worked with Members of Congress from both Florida and California to remove provisions directly and indirectly eliminating legal immigrants from student loan and grant programs. At M-DCC, approximately 8,000 students would have been affected by these provisions with an estimated loss of \$28 million to the College.

Mr. Gill also worked successfully with M-DCC to attract \$150,000 through the Commerce, Justice and State Appropriations bill for an Entrepreneurial Education Center. Also assisted M-DCC in securing \$1 million through Aeronautics and Space Transportation section of the VA/HUD Appropriations bill to develop a technology-oriented business incubator in Homestead, Florida.

  - *Fiscal Year 2007* \$2.5 million for the Science and Technology Center from the Energy and Water Appropriations Bill.

- Fiscal Year 2006 \$2 million the Energy and Water Appropriations Bill for the Science Center; \$300,000 for the Forensics Laboratory from the Commerce, Justice and Related Agencies Appropriations Bill; and \$1.7 million for a Pedestrian Walkway between Claflin and South Carolina State University from the Transportation Appropriations Bill.

#### 3.0 Personnel Qualifications and Availability

#### 3.2 Availability and Responsiveness

Venable will give the City immediate access to our team of attorneys and legislative professionals, as well as widespread sharing of our knowledge and information to help the City meet its advocacy, scheduling and budgetary goals. We are known for timely and responsive client service. Our policy is to respond promptly to client telephone calls and email messages. Our attorneys have wireless, email-enabled devices and, as such, are continuously available. Calls and messages will be returned within 24 hours, either by the principal or, in that person's absence, by a designated attorney. Further, the team will conduct weekly meetings that will allow each team member to provide status and respond to inquiries if a team member is, or will be, unable available for any reason. Through this regular communication, it is our expectation that the City will have an informed, consistently available, highly responsive team.

Venable will be available not only to the City, but to members of Congress and their staffs, governmental agencies and other key individuals who are critical to effective legislative advocacy. Our Washington, DC location facilitates meetings with key contacts, attending hearings, delivering testimony and performing other functions that are part of the legislative advocacy process. City officials are encouraged to use our office space while they are in Washington.

#### 4.0 Implementation of Scope of Services

#### 4.1 Proposed Methodology

Venable understands that the City requires competent, strategic, and aggressive legislative advocacy before the United States Congress, Executive Branch agencies, federal administrative agencies, and departments and other entities of the United States government. Venable further understands that such services will be designed to assist the City in securing funding, influencing policy, and furthering favorable legislation and executive action, strategically and effectively.

As described above, Venable has a depth of experience in representing its clients interests before all of the entities necessary to further the City's agenda, including legislative committee hearings and meetings, rulemaking proceedings or other administrative or legislative agency meetings, and audiences with individual legislators, legislative staff and Executive Branch personnel. Over the years, our attorneys and legislative advisors have developed an approach to legislative representation that has proven to be effective and has enabled us to achieve success on behalf of our clients, with regard to policy, legislation and appropriations. However, we tailor our approach to each legislative project such that it is specific to each client challenge. We work in close collaboration with our clients to customize our recommended strategies and related activities to the client's goals, objective and needs. In so doing, we take into account such factors as the legislative and political environment, potential allies and opponents, key relationships and available resources. Our primary goal is to combine the

strengths of the client and the firm into a plan of action that is designed to achieve the client's specific set of objectives.

With decades of experience, we have a strong foundation to use as a starting point for each client. Our methodology is the result of decades of experience and a the development of a proven approach to legislative representations that have enabled Venable's legislative personnel to achieve success on behalf of their clients, with regard to policy, legislation, appropriations, and the media. Our primary goal is to combine the strengths of our team and the City into a plan of action designed to achieve the City's specific goals, and address all of the elements of the City's Scope of Services, as set forth in the RFP.

While we propose to proceed as outlined generally below, we will tailor our approach to the City's specific interests, using our experience and relationships to the City's advantage.

Our proposed approach for representing the City is outlined below.

#### **Managing the Relationship**

If our team is selected for this engagement, Gregory M. Gill will be the Project Manager and Relationship Manager for the City, and will coordinate provision of the legislative services requested by the City, including the Scope of Work services set forth in the RFP. However, the City's personnel will have direct access to our team and to other professionals at our firm, as necessary. In his role as Relationship Manager, Mr. Gill will lead our team; will manage billing and contract compliance; and will be the primary point of contact for the City.

#### **Defining Issues**

The foundation for any effective legislative program is a clear understanding of the issues. We understand that, in recent legislative cycles, the City of Key West has sought federal funding from the Energy and Water Development Appropriations Bill, the U.S. Army Corps of Engineers, the Transportation and Housing and Urban Development Appropriations Bill, and the Commerce Justice Science Appropriations Bill, for issues such as:

- Environmental infrastructure program for water quality improvements in the Florida Keys
- Building a transit facility
- Extension of a ferry terminal pier
- Economic development
- · Community block grant program
- Law enforcement technology

We also understand that legislative advocacy has involved issues such as seeking to change or delay implementation of certain EPA water quality rules for Florida.

As a first step, we will take appropriate steps gain an in-depth understanding of the City's legislative issues, and to ensure that all team members – the City's and Venable's – understand every issue, the

underlying legal or policy considerations driving the issue, the potential outcomes, the City's desired outcome, and factors that could impact the outcome. We will begin by reviewing the City's legislative goals and priorities for the prior year. To understand and define issues fully, and to ensure a strong, consistent legislative program, we will integrate our efforts with the City Manager and/or his designee to obtain all necessary project information, and we will accomplish the objectives of Scope of Services requirement #1.

#### **Planning and Establishing Strategy**

The attorneys and other professionals comprising this integrated team understand the technical, fiscal and political aspects of existing and proposed legislation. Venable, in collaboration with the City, will develop and execute a strategic legislative and appropriations advocacy plan – encompassing the City's objectives and requirements at the federal level – that will include clearly defined legislative and appropriations strategies that reflect our broad understanding.

Venable has significant experience in developing lobbying strategies. In one instance, for example, legislation was on a glide path to passage in the House of Representatives. In the eleventh hour, one of our lobbyists was retained to kill the legislation and develop a compromise. After a massive lobbying effort, the bill was killed, but there were very harsh feelings among interested parties on both sides. We worked with both sides to develop a compromise strategy that included an international accord instead of federal legislation.

In another instance, a client's request was not supported by either of their two U.S. Senators, for complicated reasons. Their Congressman also was unable to gain traction with the relevant subcommittee chairman on the House side. We developed a strategy of going to another Congressman on the panel from the same state as the client. He was able to break the log jam at the subcommittee. The subcommittee funded the request and the two senators were "forced" to support it after it made it out of the House of Representatives.

We will work closely with the City's personnel to assess and evaluate key political issues and opportunities that enable us to define and establish primary objectives. We will develop comprehensive strategies to achieve those objectives, applying creativity when necessary, as described above. Our strategies will be based on our experience, knowledge and findings with regard to any specific matter.

Our legislative strategies will be consistent with the City's objectives and the requirements of the RFP, will minimize risk to the City, and will be both legal and ethical. Our collaborative method of strategy development ensures that our team will be aligned with the City's objectives, as implemented by the City's staff. Once the City has approved our recommended strategic plan for legislative activities and appropriations advocacy, or otherwise made a final determination with regard to strategy, we will match the appropriate team members and other personnel to matters assigned to us, based on the knowledge, experience and relationships required for each given matter, and always with an eye towards containing costs without compromising the quality of our services.

#### Implementing the City's Federal Government Relations and Appropriations Advocacy Program

We will provide a full range of lobbying, legislative counsel and advocacy services, including advising the City of the status of legislation while Congress is in session. We will use our strong relationships with governmental and non-governmental entities and individuals to advance the City's agenda. Working in cooperation and coordination with the City Manager and/or his designee, to ensure a cohesive effort, we will execute the tasks addressed in Scope of Services requirements #3 - #13 in implementing the City's strategic legislative and appropriations advocacy plans.

#### **Identifying and Pursuing Funding Opportunities**

#### Appropriations and Authorizations

Typically, municipalities focus primarily on the appropriations subcommittees that are relevant to their interests, as the primary sources of funding opportunities. Such committees and agencies would have program authority that matches the City's needs. While we will pursue these avenues, it is important to note that these committees are not the sole sources of funding. We also would target authorization bills that could be helpful in any number of ways, as well as direct appeals for assistance to the Executive Branch agencies. We will bring our experience to bear as we identify and analyze traditional and non-traditional opportunities.

An additional point should not be overlooked regarding targeted selection bills. The City and its legislative representatives will need to stay focused on the specific appropriations and authorization bills that are more likely to be enacted into law than others, and pursue legislative vehicles that will become law.

The appropriations funding process in this arena is highly Member- and district-by-district oriented. This can pose a challenge to the City. To represent the City effectively, Venable would need to understand current mechanisms used to establish priorities and perhaps make recommendations as to how to improve this process.

#### **Grants and Grant Administration**

In addition to appropriations and authorizations, Venable would pursue grant funding. We have significant experience with grant funding related to homeland security (including FEMA), commerce, energy, education and other issues. In addition, we have several avenues for exposure to grant funding opportunities. For example, Venable has one of the most well-respected nonprofit practices in the country, which provides our attorneys with steady exposure to grant procurements at agencies across the federal government. Our Government Contracts group is another source of leads. Venable will support the City's efforts in pursuit of federal grant opportunities.

Venable also has broad experience in counseling grant recipients, having advised many clients on issues related to federal grant programs, including compliance with cost principles and other regulatory requirements applicable to grant recipients from sources such as state and local governments, educational institutions, and nonprofit organizations. #### Reporting

We will provide reports in according with Scope of Services requirement #14. Specifically, we will provide quarterly reports to the City Manager demonstrating our progress toward securing funding for City projects. The report will provide sufficient information as needed for the City Commission, City Manager and staff to support any lobbying strategies. We also will appear before the City Commission to report on and demonstrate our progress toward securing funding for the City's projects, as set forth in Scope of Services requirement #15.

Our reports also will include recommendations for future actions on any issues. A sample of our report format is provided in Appendix D. We will modify our standard report, as needed, to ensure that it conforms to the City's requirements for format and level of detail.

#### **Ensuring Issue Resolution and Timeliness**

We will make every effort to handle the City's matters and resolve issues in a timely, cost-effective manner. We will establish and manage schedules for every project, with the City's concurrence. We will:

- Monitor the schedule, with the City's participation
- Identify and address, early in the process, any variables that are likely to impact the desired timeline or outcome.

#### 4.2 Time Estimate

Venable's estimated timeline is based on traditional tasks associated with implementing a federal government relations and appropriations advocacy plan. Tasks may be added as necessary to address the City's issues effectively and efficiently.

Our preliminary timeline is provided below.

#### Scheduling

Venable will work with the City to modify the preliminary timeline. We are willing to meet the City's scheduling and timeframe requirements.

Venable's recent, current and projected workloads will not present an issue for the City.

#### 5.0 Fees

#### 5.1 Proposed Fee

Venable is proposing a fixed fee of \$6,000 per month, plus reasonable expenses, including local transportation, travel and lodging costs associated with travel to Key West.

#### 5.2 Fee Basis

Consistent with commercial practice in the legal services industry, Venable's rates for attorneys and legal staff are based on competitive market forces – not on the cost of providing those services.

Annually, Venable obtains results of surveys of the marketplace to use as benchmarks in establishing or adjusting our rates each year, and then, analyzes the survey data. After review of Venable's survey analysis, Venable's executive committee consults with practice group leaders, who in turn consult with firm practitioners and clients regarding whether Venable's rates are competitive with firms providing like services in similar locations, of like size, practice areas, expertise, experience, and reputation. Venable then adjusts its commercial rates based on the survey data and internal discussions.

Venable refines its rates by establishing different categories of commercial rates for each attorney so that the pricing of any matter corresponds to the particular area of law, the complexity involved, whether the issues are novel or routine, and risk. Thus, we are able to provide rates that are competitive, fair and reasonable for our clients.

In establishing rates for particular client matters, we base our fees on the hourly rates of the individual attorneys and legal services professionals who are doing the work. Typically, we then bill for our services against a monthly retainer based on estimated hours and the attorneys' rates, derived as explained above. With cost-effectiveness in mind, we reduced our hourly rates substantially to formulate a retainer that ensures fair and reasonable rates for the City. However, the City can be assured that the proposed fee reduction will not impact the quality of our representation.

Most recently, Mr. Hegg helped to garner support from Members of Congress to appropriate funds for the Maritime Security Program's new 60-ship program at \$156 million for FY'06. Mr. Hegg obtained the support of 31 of the Members who committed to the program, which was fully funded.


