2020 White Toyota**Original Narrative By Ivan Golovanov, 01/03/26 00:31**

On 01/02/2025 at approximately 2200 hours, I, Officer Golovanov, was on a routine patrol in an area of Duval Street and Charles Street wearing a full KWPD Class B uniform.

A white Toyota sedan pulled over next to me and my marked KWPD patrol vehicle with a black male driver and a white female passenger. I immediately recognized the female (Melissa L. Godin, DOB: 08/30/1982) who was causing a disturbance less than an hour ago at "Schooner Warf Bar and Grill" (202 William St.) and was later trespassed from that establishment, ref. CAD: 260000495.

The driver (Eguens Joseph, DOB: 11/29/1987) informed me that Melissa just jumped on the passenger seat of his vehicle without his permission and is now refusing to leave. I asked Melissa to leave the vehicle, but she refused. I then asked Eguens if he wished to press trespassing charges against Melissa, and he stated yes.

I opened the front passenger door and instructed Melissa to exit the vehicle, but she refused again. I pulled Melissa out of the vehicle and instructed her to place her hands behind her back. Melissa immediately tensed her hands and fought my attendants to handcuff her. I repeatedly told Melissa to place her hands behind her back; however, she continued resisting. I informed Melissa that if she does not gonna place her hands behind her back, she will go to the ground. At this moment, Melissa dropped her wail to the ground and lay on her back, and continued to resist my attempts to handcuff her, and started yelling profanities towards me. Because I was unable to turn Melissa onto her stomach, I put her back on her feet. Melissa continued resisting me, so I performed a takedown and redirected her to the ground in a controlled manner. Melissa continued to fight my attempts to handcuff her, continued to disobey my lawful orders, and kept yelling profanities towards me.

I activated my department-issued Taser and informed Melissa that I would tase her if she not comply. Melissa continued resisting, so I drive stunned her to the upper back area. Melissa continued resisting, so I again drive stunned her into her upper back area between her shoulder blades. At this moment, Melissa complied and placed her hands behind her back, and I handcuffed her.

It is to be noted that while Melissa was resisting my attempts to handcuff her, bystanders were stopping what they were doing and were offering their help with handcuffing Melissa.

At this moment, Sergeant Waite and Ofc. Andrade arrived on the scene.

I walked Melissa towards the front of my vehicle, where she was searched with my Fleet camera operating. Melissa was then placed in the back of my patrol car.

Eguens informed me that he is an Uber driver and that Melissa jumped into his car on Duval St. I double-checked with Eguens whether Melissa was the person who requested a ride through the Uber App, but he replied no. Eguens stated that he had told Melissa multiple times to exit his vehicle, and she refused. Eguens also mentioned that Melissa offered him sex from which he refused. Eguens also informed me that during the incident, Melissa struck him inside his vehicle; however, he refused to press any battery charges against Melissa.

Sgt. Waite and I transported Melissa to Lower Keys Medical Center (LKMC) for medical clearance. Inside LKMC, Melissa stated that she was drinking and smoking marijuana earlier today. It is worth noting that Melissa had a large metal to-go bottle of red wine. After Melissa was medically cleared, I transported her to MCDC without incident.

Based on the facts and evidence in this case, I believe that Melissa L. Godin violated FSS 810.08-2b trespassing, occupied structure or conveyance. Melissa wilfully and intentionally entered an occupied vehicle without permission, then refused to exit it after the driver's orders, and then after my.

Based on the facts and evidence in this case, I believe that Melissa L. Godin violated FSS 843.02, resisting without violence. Melissa wilfully and intentionally refused to obey multiple of my lawful orders and kept fighting my attempts to handcuff her to the point that I had to use force to handcuff her.

Based on the facts and evidence in this case, I believe that Melissa L. Godin violated FSS 877.03 disorderly conduct. Melissa's actions of fighting me in the middle of a busy street on a busy Friday night, causing bystanders to stop what they were doing and offering me help to handcuff her, affected the peace and quiet of people who witnessed her actions.

My BWC, in-car, and Fleet cameras were operating during this incident and uploaded to Evidence.com.
