**A RESOLUTION OF THE CITY COMMISSION OF THE  
CITY OF KEY WEST, FLORIDA, AUTHORIZING THE  
DUVAL LOOP FIXED ROUTE CIRCULATOR TO FARE-  
PAYMENT SERVICE; AUTHORIZING A ONE DOLLAR  
(\$1.00) FARE AND PASS USAGE FOR ALL-DAY AND  
7-DAY PASSES; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the free Duval Loop circulator commenced in 2018, with 50% grant funding from the FDOT Service Development Grant Program; and

WHEREAS, the Duval Loop provided more than 1,200,000 trips to tourists and locals since its inception, furnishing a valuable public service and supporting reductions in automobile traffic in the most heavily travelled area of Key West; and

WHEREAS, since 2022 the Duval Loop has been classified as a city route and received funding through the current city route grant program (Cost sharing: State 50%; City 50), and City staff recommends continuing the Duval Loop, and transition the Duval Loop from fare-free to fare-payment service; imposing a \$1 per trip fare, purchase and usage of all-day (\$4) and 7-day (\$8) passes to reduce the potential burden of the Duval Loop expenses on the City's General Funds; and

WHEREAS, the City Commission finds it would be beneficial to the City of Key West to charge a \$1.00 fare for use of the Duval Loop.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Duval Loop will transition to a fare-payment service.

Section 2: That a \$1.00 fare is established for each trip on the Duval Loop.

Section 3: That passengers may purchase and use all-day passes for a fare of \$4.00 and a 7-day pay for a fare of \$8.00.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
