**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING HEMINGWAY SUNSET RUN & PADDLEBOARD LLC TO HOLD THE 36<sup>TH</sup> ANNUAL HEMINGWAY 5K SUNSET RUN ON SATURDAY, JULY 26, 2025, FROM 7:15 P.M. TO 8:15 P.M. WITHIN THE STREETS OF KEY WEST; AUTHORIZING THE CLOSURE OF CERTAIN STREETS OR PORTIONS THEREOF FOR SAID RACE FROM 7:15 P.M. TO 8:15 P.M; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, Hemingway Sunset Run & Paddleboard Race LLC wishes to conduct the "36<sup>th</sup> Annual Hemingway 5K Sunset Run" beginning and ending at the United Street & Whitehead Street during the hours of 7:15 p.m. to 8:15 p.m. on Saturday, July 26, 2025.

BE IT RESOLVED by the City Commission of the City of Key West, Florida, as follows:

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using

disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That 36<sup>th</sup> Annual Hemingway 5K Sunset Run is hereby granted permission to hold the "36<sup>th</sup> Annual Hemingway 5K Sunset Run" starting and ending at United Street and Whitehead Street on Saturday, July 26, 2025, from 7:15 p.m. to 8:15 p.m.

SECTION 4. That the City Manager has discretion to non-materially change the route depending on construction detouring.

SECTION 5. That Hemingway Sunset Run & Paddleboard Race LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That Hemingway Sunset Run & Paddleboard Race LLC will make a donation to the Key West Sunrise Rotary.

SECTION 7. That Hemingway Sunset Run & Paddleboard Race LLC acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community

Services.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
