WHEREAS, The City Commission for the City of Key West, having reviewed all of the documents, summaries, and recommendations associated with the above circuit court litigation, hereby resolves that executing a settlement agreement is in the city's best financial interests; and

WHEREAS, The City Commission for the City of Key West resolves to authorize the city manager to execute all settlement documents with the advice and consent of the city attorney; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached settlement agreement between the City of Key West and Harborside, LLC in Case No. 2023-CA-550-K is hereby approved.

Section 2: The City of Key West agrees to accept \$500,000.00 as full satisfaction of all arrearages concerning the parking agreement entered into on or about July 25, 2012. Additionally, the parking agreement between the City of Key West and Harborside, LLC will be amended to reflect an annual fixed payment of \$25,000.00 for 26 non-dedicated parking spaces at the Caroline Street Lot. The City Manager shall be authorized to execute all settlement documents with the advice and consent of the city attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
