A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MEL FISHER DAYS, INC. TO CONDUCT A 2014 CELEBRATION OF THE FINDING OF THE ATOCHA ON SATURDAY, JULY 12, 2014 DURING THE HOURS OF 11:00 A.M. TO 9:00 P.M. AUTHORIZING THE CLOSURE OF THE 100 & 200 BLOCK OF DUVAL STREET INCLUDING GREENE STREET FROM TELEGRAPH LANE TO ANN STREETS FROM 8:00 A.M. TO 11:00 P.M.; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 8:00 A.M. TO 11:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Mel Fisher Days Inc. has applied to the City for a Special Event Permit for A Celebration of the finding of the "Atocha" Saturday, July 12, 2014; and

WHEREAS, this event shall take place on the 100 & 200 block of Duval Street between the hours of 11:00 p.m. to 9:00 p.m; and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida:

SECTION 1. That Mel Fisher Days, Inc. is hereby granted permission to conduct an Anniversary Celebration of the finding of the Atocha on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25 % of gross revenue or \$1,000.00, whichever is more, shall be donated to the Wesley House Family Services, Inc..

SECTION 2. That Mel Fisher Days, Inc. is hereby granted permission for the closure of the 100 & 200 block of Duval Street including Greene Street between Telegraph Lane & Ann

Street on the date and during the hours stated above.

SECTION 3. That Mel Fisher Days, Inc. is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, Mel Fisher Days, Inc is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That Mel Fisher Days, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side;

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
