A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING BAYSHORE PRODUCTIONS, INC. TO CONDUCT A "VERIZON MUSIC FESTIVAL" AT MALLORY SQUARE ON FRIDAY, JUNE 1, 2012 FROM 4:00 P.M. TO 11:00 P.M. (SET UP STARTING AT 7:00 AM); SATURDAY, JUNE 2, 2012 FROM 12:00 NOON TO 11:00 P.M. AND SUNDAY, JUNE 3, 2012 FROM 12:00 NOON TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 4:00 P.M. TO 11:00 P.M. ON FRIDAY, JUNE 1, 2012, FROM 12:00 NOON TO 11:00 P.M. ON SATURDAY, JUNE 2, 2012 AND FROM 12:00 NOON TO 11:00 P.M. ON SUNDAY, JUNE 3, 2012; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Bayshore Productions, Inc. has applied to the City for a Special Event Permit for a "Verizon Music Festival" at Mallory Square starting on Friday, June 1, 2012 through Sunday, June 3, 2012.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida;

SECTION 1. That Bayshore Productions, Inc. is hereby granted permission to conduct a "Verizon Music Festival" on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

SECTION 2. That Bayshore Productions, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 3. That Bayshore Productions, Inc. is hereby granted a Special Event Permit

under Section 6-86 of the Key West of Ordinances for an event that will take place and time herein described.

SECTION 4. Bayshore Productions will pay the parking fees at Mallory Square to set up for vehicles and event staff parking at a rate of \$4.00 per hour or \$32.00 per day per parking space.

SECTION 5. Bayshore Productions shall pay the City of Key West a user fee of \$500.00 per day for the use of Mallory Square.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
