**Re:** Amended Notice of Appeal of Planning Director's Administrative Decision

Dear Keri,

Please allow this correspondence to serve as an Amended Notice of Appeal of the determination of the City of Key West Planning Director's decision provided in the City of Key West Licensing Official concerning the Business Tax Receipt for KW Boardwalk, LLC ("Applicant").

Pursuant to Key West, FL, Code § 90-301(b) "[t]he city planner shall have the administrative responsibility to interpret the land development regulations. Such interpretations shall be in writing and accompanied by review and written consent by the city attorney." The planning director's interpretation was provided via the Licensing Official. Pursuant to Key West, FL, Code § 90-426 "administrative and enforcement decisions by the city planner and chief building official may be appealed to the city commission." The planning decision was issued to the Applicant on January 17, 2025, attached hereto **Exhibit A** and the appeal was timely made on January 22, 2025. Pursuant to Key West, FL, Code § 90-426, an applicant may appeal a decision of the planning director to the City Commission by providing the City Clerk notice of appeal within ten (10) calendar days following the decision of the planning director. Check number 9094 in the amount of \$2,552.56 was provided on January 22, 2025 for payment of the fee for the appeal to the City Commission.
