A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING "INTERLOCAL ATTACHED **AGREEMENT** PURSUANT TO CHAPTER 163, FLORIDA STATUTES, FOR PUBLIC SCHOOL FACILITY JOINT USE POINCIANA PLANNING AND OF ELEMENTARY SCHOOL, HORACE O' BRYANT SCHOOL, GERALD ADAMS ELEMENTARY SCHOOL, AND KEY WEST HIGH SCHOOL SPORTS AND FACILITIES" RECREATIONAL BETWEEN THE DISTRICT SCHOOL BOARD OF MONROE COUNTY, FLORIDA AND THE CITY OF KEY PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Chapter 163, Florida Statutes, known as the "Florida Interlocal Cooperation Act Of 1969" ("the Act"), specifically provides that its' purpose is to "permit local governmental units to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities"; and

WHEREAS, the District School Board of Monroe County ("School Board") owns the facilities known as Poinciana

Elementary School, Horace O'Bryant School, Gerald Adams
Elementary School, and Key West High School, and the City of
Key West intends to join with the School District to manage
the use of athletic fields for programs benefitting the
public; and

WHEREAS, at a public meeting on April 25, 2024, the Key West Parks and Recreation Advisory <u>Board</u>, in PRAB Resolution No. 24-03, recommended approval of the attached <u>an</u> Interlocal Agreement <u>regarding use of recreational fields at Gerald Adams</u>, <u>Poinciana Elementary</u>, H.O.B., and Key West High School; and

WHEREAS, at a public meeting on October 24, 2024, the

Key West Parks and Recreation Advisory Board approved an

Amended Interlocal Agreement for use of recreational fields

with the exception of Key West High School and the hockey

facility at Key West High School; and,

WHEREAS, it is the desire of the City and the School

District to bring a separate Interlocal Agreement outlining

the use of Key West High School for a hockey facility at a

later date,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached "Interlocal Agreement Pursuant to Chapter 163, Florida Statutes for Public School Facility Planning and Joint Use of Poinciana Elementary School, Horace O'Bryant School, Gerald Adams Elementary School and Key West High School Sports and Recreational Facilities," between the District School Board of Monroe County and the City of Key West is hereby approved.

Section 2: The Interim City Manager is authorized to execute any and all documents consistent with this Resolution with the advice and consent of the City Attorney.

Section $\frac{2}{3}$: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
