A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) VENTRAC 4500 SERIES TRACTOR AND ACCESSORIES TILT MOWER FROM JACOBSEN SOUTH FLORIDA IN AN AMOUNT NOT TO EXCEED \$33,464.55 THROUGH STATE OF FLORIDA CONTRACT #22101000-15-1, PURSUANT TO SECTION 2-797(3) AND 2-797(4) OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to State government contracts; and

WHEREAS, certain accessories, available only pursuant to open market pricing, in the amount of \$13,628.55, are also included in the Ventrac 4500 price quote; and

WHEREAS, City staff reviewed all open market items and has determined that open market pricing is fair, reasonable and consistent with prices available from other vendors, and so the purchase is in the best interests of the City pursuant to section 2-797(4) (b) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) Ventrac 4500 Series Tractor and Accessories Tilt Mower, with accessories, for an amount not to exceed \$33,464.55, from Jacobsen South Florida is hereby approved, pursuant to Section 2-797(3) and 2-797(4) of the Code of Ordinances.

Section 2: That \$19,836.00 of the purchase price is authorized pursuant Section 2-797(3) of the Code of ordinances, under State of Florida Contract 22101000-15-1, and \$13,628.55 of the purchase price is authorized pursuant to section 2-797(4)(b), best interests of the City.

Section 3: That adequate funds for this purchase are budgeted in FY 2017 Solid Waste Fund under Machinery and Equipment Account No. 403-3407-534-6400.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
