On October 30, 2022, at approximately 0120 hours, I, Ofc. S. Ham was dispatched to 1075 Duval St. (Circle K), reference a physical disturbance.

Upon arrival, a group of males walked past me as I approached the establishment. The suspect later identified as Matthew Tidwell, was bleeding from the face. Matthew matched the description of the suspect provided by KWPD dispatch. I pulled my TASER as I approached Matthew because KWPD dispatch advised that Matthew had just fought one male and was attempting to fight others. I then saw that Matthew had a filet knife with an orange handle in his right hand. I instructed Matthew to drop the knife and he did. I gave Matthew a few commands to step away from the knife and take a seat. Matthew eventually backed away from the knife and approached the wall beside Circle K.

There was a small crowd of people standing around the establishment as I continued to tell Matthew to sit down. Matthew stated he was going to have a seat on the steps of the establishment. Matthew took a few steps towards the establishment and then turned towards me. Matthew yelled stating that he wasn't going to sit down, and I was going to have to tase him. Matthew turned away from me and acted as if he was going to walk away. I told Matthew to stop, or he was going to be tased. Matthew stopped and turned towards me yelling I was going to have to tase him. Matthew then took a step towards me. I told Matthew to not take another step and he did. I deployed my TASER, striking Matthew in the torso. Matthew fell to the ground as he experienced NMI (neuromuscular incapacitation). Matthew attempted to remove the probes once he was on the ground, and I deployed another five-second cycle, once again achieving NMI. Matthew's cooperation increased, and I was able to place him into handcuffs. I maintained control of Matthew sitting on the sidewalk while Ofc. S. Adorno and Ofc. A. Ane spoke to witnesses on scene.

Ofc. S. Adorno stated to me that only one of the witnesses saw the altercation from the beginning. Ofc. Adorno stated to me the other three witnesses only saw Matthew walking back from his bicycle with the knife yelling that he was going to kill him. Ofc. Adorno stated the witness that saw the entire altercation was identified by his Florida ID card as Danny Reed. Ofc. Adorno stated the following to me that he was advised from Danny: Danny stated that Matthew was yelling at a family that was walking on the opposite side of the street. Danny stated the mother, told the father not to engage Matthew. Danny stated they had a young child approximately 10 years old. Danny stated Matthew went after the kid in an aggressive manner, as if he was going to attack him. Danny stated the father got between them and punched Matthew once in the face. Danny stated Matthew went down to the ground and the father of the kid began to walk away. Danny stated Matthew got up and ran towards his bicycle near Duval square to grab a knife. Danny stated Matthew ran back towards the front of Circle K holding the filet knife. Danny stated Matthew was irate with the knife yelling "where did he go, I'm going to kill him." Danny stated Matthew did not threaten anyone else there with the knife, just held it in his hand.

I spoke with Ofc. A. Ane who stated he spoke with the original reporting party and witness (Gene Kinder). Ofc. Ane stated the following to me that he was advised by Gene: Gene stated he saw Matthew kicking over trash cans and trying to fight everyone. Gene stated that he watched Matthew try and throw punches with one other male and then he called 911. Gene stated he did not see Matthew walk back to his bicycle to obtain the knife.

Ofc. L. Hernandez collected the filet knife and submitted it into KWPD property and evidence.

Key West Rescue personnel arrived on scene and removed the TASER prongs. Key West Rescue personnel attempted to clean up Matthew's face and inspect for injuries, but Matthew began spitting. Matthew was placed in a spit hood by Ofc. Hernandez. Key West Rescue transported Matthew to Lower Keys Medical Center without incident. I rode with Key West Rescue to assist with transport.

Matthew was looked over by doctor and taken in for a CT scan. Doctor at the ER advised me that Matthew had

sustained a broken nose and nothing else. Matthew was medically cleared by the ER.

I transported Matthew to Monroe County Detention Center without incident. Upon arrival, Monroe County nursing staff denied Matthew for uncontrolled bleeding from his nose. I transported Matthew back to Lower Keys Medical Center for another medical clearance. Matthew was cleaned up at the ER and medically cleared a second time.

Matthew was kicking over garbage cans and attempting to fight people passing by. Matthew was struck one time in the face for attempting to attack the unknown male's son. Matthew then retrieved a filet knife from his bicycle and began yelling to everyone, "where did he go, I'm going to kill him." Matthew was holding a filet knife in his hands and yelling when I arrived on scene. There is probable cause to believe that Matthew was in violation of F.S.S. 877.03 Disorderly Conduct.

Matthew was holding a filet knife in his right hand when I arrived and refused to take a seat after dropping the knife. I gave Matthew multiple commands to sit down and not approach me. Matthew refused to listen and began to approach me after multiple warnings. I deployed my TASER striking him in the chest and lower abdomen. Matthew was in violation of F.S.S. 843.02 Resisting without violence.

My Axon BWC, Axon Fleet in-car and TASER video camera were activated and uploaded.
