

RESOLUTION NO. 24-022

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST (CITY) AWARDING THE BID OF PEDRO FALCON, INC., IN RESPONSE TO BID ITB #24-002 FOR THE REPAIRS TO THE SMATHERS BEACH PAVILIONS (PROJECT IS72012303) FOR A TOTAL AMOUNT OF \$178,650.00; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, in Resolution 22-194, the City Commission approved the Monroe County Tourist Development Council (TDC) grant in the amount of \$198,000.00 for the repair of the Smathers Beach Pavilions; and

WHEREAS, City staff advertised a request for bids, ITB #24-002 for the repairs to the Smathers Beach Pavilions, and five bids were received; and

WHEREAS, City staff reviewed bids received in response to ITB #24-002 and determined the bid of Pedro Falcon, Inc. to be the lowest responsive bid; and

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF KEY WEST, AS FOLLOWS:

Section 1: That bid of Pedro Falcon, Inc. in response to ITB #24-002 Smathers Beach Pavilions, in the amount of \$178,650.00 is hereby awarded.

Section 2: That the project is budgeted in account #101-7201-572-6300 (Infrastructure/Parks and Recreation/Infrastructure) Project #IS72012303.

Section 3: That the City Manager is authorized to execute documents related to this Task Order, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
