**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING SEVEN SLOT SALES, LLC DBA BLINKERFLUID PRODUCTIONS TO CONDUCT A "KEY WEST JEEP INVASION" AT THE TRUMAN WATERFRONT 103 FIELD, PARKING LOT, QUAY WALL, PLAYGROUND SIDE OF BOAT RAMP, AND THE GRAVEL LOT ON FRIDAY, MARCH 12, 2027 AND SATURDAY, MARCH 13, 2027, FROM 10:00 A.M. TO 4:00 P.M (SETUP THURSDAY, MARCH 11, 2027); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, Seven Slot Sales, LLC DBA Blinkerfluid Productions has applied to the city for a Special Event Permit for a "Key West Jeep Invasion" at the Key West Truman Waterfront Park 103 Field, Parking Lot, Quay Wall, playground side of the boat ramp, and the gravel lot for a 'Show & Shine', Friday, March 12, 2027 and Saturday, March 13, 2027, from 10:00 a.m. to 4:00 p.m. with setup on Thursday, March 11, 2027.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That Seven Slot Sales, LLC DBA Blinkerfluid Productions is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Seven Slot Sales, LLC DBA Blinkerfluid Productions is hereby granted permission for the use of the Key West Truman Waterfront Park 103 Field, Parking Lot, Quay Wall, playground side of the boat ramp, and the gravel lot.

SECTION 5. That Seven Slot Sales, LLC DBA Blinkerfluid Productions will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That Seven Slot Sales, LLC DBA Blinkerfluid

Productions acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 7. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
