FEE STRUCTURE

Our firm would provide our government rate of \$235.00 per hour for attorneys and \$155.00 per hour for paralegals.

If the City prefers, we can offer a hybrid retainer and hourly arrangement, which we use with most of our local government clients. The retainer (monthly flat fee) would include all of the City's regular, special and workshop meetings as well as all communications with City Commissioners on an unlimited basis. This retainer would be in conjunction with an hourly arrangement for other needed legal work that is not really capable of a defined amount of effort on a regular basis. Our current clients realize a return on investment by utilizing the retainer option as time spent in meetings and addressing individual elected official's matters typically exceeds what we would normally bill for such services. This model provides elected officials comfort that they may contact their legal counsel without concern of excess billing and allows legal to work proactively with the elected officials. We would need about two months of working hourly in order to determine the City's utilization and create a hybrid structure accordingly.
