COMMENT: KEYS has no objection to the Transfer of a Transient Unit
License request.

LOCATION: Minor Development Plan - 601 Howard England Way

COMMENT: KEYS has no objection to the Minor Development Plan
request. KEYS has overhead power lines that will service this
project. KEYS will need to have a full set of plans and a
project review form to ensure adequate power is supplied
for the new project and the existing customers.

LOCATION: Major Development Plan - Unaddressed Lot

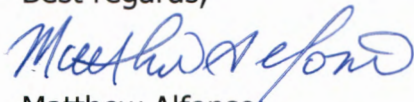
COMMENT: KEYS will provide high voltage underground per KEYS
policies and tariffs. KEYS will need to have a full set of plans
and a project review form to ensure adequate power is
supplied for the new project and the existing customers.

LOCATION: Minor Development Plan - 218 Duval Street

COMMENT: KEYS objects to the Minor Development Plan request. KEYS has a concrete service pole (A17-A) that provides power to 220 & 220 ½ Duval St. This proposed new construction and new food truck would eliminate bucket truck access. Prior to proceeding the developer must relocate the services to Telegraph Ln. KEYS can meet in the field and to assist in developing alternate electrical service to 220 & 220 ½ Duval St.
