A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF (6) 2026 FORD INTERCEPTOR PATROL VEHICLES, (1) 2026 FORD F-250 PICK-UP TRUCK, AND (1) 2026 FORD TRANSIT PRISONER TRANSPORT VAN AT A TOTAL AMOUNT NOT TO EXCEED \$527,519.34, FROM BARTOW FORD, UNDER THE PASCO COUNTY PURCHASING CONTRACT NO. IFB-RR-21-042, PURSUANT TO SECTION 2-797(3)- PURCHASES UNDER GOVERNMENT CONTRACT, AND 2-797(4)(b)- BEST INTERESTS, OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST POLICE DEPARTMENT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Police Department is budgeted in FY 25/26 to replace certain vehicles that have exceeded their useful and reliable service life; and

WHEREAS, this purchase will be made under the Pasco County Purchasing Contract No. IFB-RR-2-042 and related extensions, pursuant to section 2-797(3)- Purchase Under Government Contract, and 2-797 (4)(b) - Best Interest, of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of (6) 2026 Ford Interceptor Patrol Vehicles, (1) 2026 Ford F-250 Pick-up Truck, and (1) 2026 Ford Transit Prisoner Transport Van, as described in the attached

proposal of Bartow Ford, pursuant to section 2-797(3), and 2-797(4)(b) of the Code of Ordinances, under the Pasco County Government Purchasing Contract No. IFB-RR-21-042, in an amount not to exceed \$527,519.34, is hereby authorized for use by the Key West Police Department.

Section 2: That funds for this purchase are budgeted in FY 25/26 under account number 101-2101-521-6400. Any necessary budget adjustments and transfers are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
