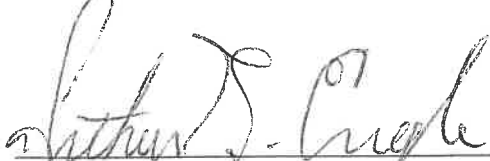

- This complaint and any attachment become public record. If you have already filed a report with Key West Police Department Internal Affairs, and you want that complaint to remain confidential until the investigation is complete, you may want to refrain from filing at this time.
- Complaints should be filed as soon as possible of the time you became aware of the incident or after resolution of any criminal charges.
- Anyone who has criminal charges pending related to this complaint should consult an attorney before filing the complaint with the CRB and such pending charges may delay the progress of the investigation of your complaint with the CRB. Further, any statements made to the CRB are public record and can be used by anyone to incriminate the complainant. All statements will be uploaded to the internet.
- Complainants must advise the CRB of any changes of address or phone number; failure to provide the CRB current information or means for CRB to contact the complainant may result in dismissal of the case.
- All documents received by this office, including medical records, photo IDs, communications and alike become public records and will be disclosed on the Internet and viewable by anyone or any person. You should consider this fact before sending any matters or materials to this office.
- The CRB and its employees and agents are not your legal representatives. You should seek independent legal representations to understand your legal rights regarding the matters referenced in your complaint.
- The CRB jurisdiction is limited to City of Key West Police Officers and NOT Monroe county sheriffs, correction officers, Florida Fish and Wildlife Officers, FDLE representatives, Florida Highway Patrol Officers, Federal Agents, Military personal and alike.

ON THE 24TH OF APRIL, 2025, AT ABOUT 5 MINUTES AFTER 8PM I WAS ON MY WAY HOME FROM WORK. I SIGNALLED RIGHT FROM N. ROOSEVELT BLVD. ONTO 7TH STREET BETWEEN FAIRFIELD INN AND THE STARBUCKS. I HAD NOTICED A BLACK OR DARK COLORED PICK UP TRUCK BEHIND, THEN BESIDE, AND THEN BEHIND ME AGAIN. WHEN I SIGNALLED AND TURNED RIGHT, THE OTHER VEHICLE ALSO TURNED. I WAS UNDER THE IMPRESSION THE OCCUPANTS WERE UNFAMILIAR WITH THE AREA. AT HARRIS STREET STOP WITH THE FLASHING RED LIGHT, I MADE A LEFT TURN WITH MY TURN-SIGNAL TO THE LEFT, IN THE ON AND WORKING POSITION

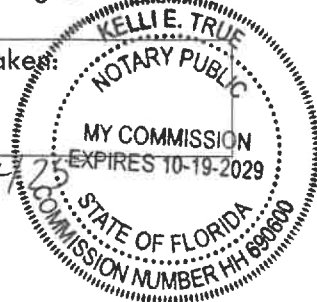

AFTER COMPLETING MY LEFT TURN I SAW THE VEHICLE BEHIND ME MAKE THE RIGHT TURN, AND IT DIDN'T APPEAR HE/SHE HAD SIGNALLED THEIR TURN. IN MY MIND I HAD A BRIEF THOUGHT, "WELL, THESE FOLKS ARE LIKELY LOST OR UBER LOOKING ASPECIFIC ADDRESS AND GAVE THEM ZERO INTEREST. MAYB THEY'RE TALKING ON PHONE, OR PUNCHING AN ADDRESS IN A GPS?" NEARLY TO THE NEXT STOP SIGN I BEGAN SCANNING THE AREA AS I LIVED ONLY A FEW FEET FROM THERE AND ~~AS I CAME TO~~ WAS HOPING FOR A PARKING PLACE IN ONE OF MY REGULAR PARKING SPACE.

IT WAS AT ABOUT THIS MOMENT WHILE STOPPING AT STOP SIGN, THAT A KWPD OFFICER PUT ON HIS LIGHTS AND SIRENS. I KNEW I HAD NOT BROKEN ANY TRAFFC ORDANCES, OR LAWS, SO AFTER THE STOP AT THE SIGN, I PULLED THROUGH THE SIGN & INTERSECTION TO GET TO AN ALTERNATE PARKING SPACE I'VE USED ON PAST NIGHTS. WANTED THE POLICE CROUSER TO BE CLEAR TO MAKE A TURN THERE AT 8TH AND HARRIS. I DID NOT KNOW THAT THE OFFICER (RUSSELL HOLMES) WANTED TO STOP ME! WHEN I REALIZED IT IN THE NEXT MOMENT, I WAS ALREADY PASSING A ROLL-OFF DUMPSTER AND A PINKISH/BURGANDY COLORED

SUV STYLE VEHICLE. I MADE SURE TO LEAVE ROOM FOR THE CRUISER TO ALSO PARK AS I PULLED INTO MY PARKING SPOT. THE OFFICER IS RUSSELL HOLMES OF KINPD. AT FIRST OFFICER HOLMES WAS CORDIAL & POLITE.. WHILE INTRODUCING HIMSELF. UNFORTUNATELY, HE STARTED TELLING ME THAT THEY HAD "MULTIPLE CALLS" REGARDING MY DRIVING. I KNEW THIS TO BE UNTRUE AND COULDN'T HELP BUT EXPRESS MY THOUGHTS AND SAY "I DON'T THINK SO". EVIDENTLY MY FREE SPEECH, THE 1ST AMMENDMENT HAS AFFORDED ME, MUST HAVE UPSET OFFICER HOLMES BECAUSE HE IMMEDIATELY ESCALATED HIS TEMPER AND THE WAY HE WAS TO PROCEED AT THAT POINT. I ASKED WHAT WAS WRONG WITH MY DRIVING? OFFICER HOLMES WAS AGAIN DISHONEST DURING OUR INTERACTION STATING THAT ~~THEY~~ THERE WERE "3 OR 4" CALLERS" COMPLAINING THAT I WAS DRIVING UNDER THE SPEED LIMIT (11MPH). BY THE WAY, THIS MADE NO SENSE BECAUSE I AM WELL AWARE I MADE NO MISTAKES WHILE DRIVING AND THE NEIGHBORHOOD I WAS IN HAD A SPEED LIMIT OF 15MPH! I'M AWARE THAT EVEN THOUGH I REMAINED CALM, OFC. HOLMES TOTALLY CONTINUED ESCALATING THE SITUATION, REGARDLESS OF IT BEING AN OFFICER'S OBLIGATION

TO 'DE-ESCALATE.' IT IS POSSIBLE THAT ~~HE~~ LOOKING BACK AT FOIA REQUESTED VIDEO, HE MAY HAVE BEEN BOTHERED THAT I DID NOT CARE TO ANSWER QUESTIONS THAT WERE UNRELATED TO THE ~~REASON~~ 'REASON' HE CLAIMED HE WAS STOPPING ME. I DID NOT SEE HOW MY ANSWERING WHERE I WORKED HAD ANYTHING TO DO WITH AN ALLEGED ANONYMOUS PHONE CALL. (WAS THE CALLER INVESTIGATED? IS IT OKAY TO PULL SOMEONE OVER THAT HAS MADE NO TRAFFIC INFRACTION? ALL HE WAS GOING ON WAS AN ERRONEOUS CALL.) I DO NOT WISH TO ARGUE THIS STOP HERE IN THIS FORMAL COMPLAINT. IF NEED BE IT CAN BE WORKED OUT IN COURT. I'M VERY SORRY TO SAY THIS, BUT MY RIGHTS WERE VIOLATED (SEVERAL) BY MY BEING ARRESTED, PUT IN HANDCUFFS WHEN I DID NOT AGREE TO BE ROUGHED UP AFTER BEING YANKED FROM MY VEHICLE BY A 2ND OFFICER, SEAN DAVIS. THE MARKS FROM THE HANDCUFFS ARE DOCUMENTED AFTER MY RELEASE ON A DATE/TIME STAMPED CAMERA FOR SEVERAL MORE DAYS. IF THE INTERNAL AFFAIRS DIVISION WISHES ME TO EXPLAIN FURTHER OF ALL THAT WAS HANDLED

IMPROPERLY ON THAT NIGHT, IN WRITING, I'LL BE HAPPY TO OBLIGE AFTER HEARING BACK FROM SOMEONE SOON. BRIEFLY THOUGH I HAD SEVERAL CONSTITUTIONAL & CIVIL RIGHTS VIOLATED BY ALL OFFICERS NOTED WITHIN. YES, OFFICERS LOPEZ & YOUNG WERE THE MOST PROFESSIONAL THAT NIGHT, THEY FAILED AT SPEAKING UP TO STOP AN UNFOUNDED & ULTIMATELY ILLEGAL ARREST. THAT ARREST CAUSED PHYSICAL PAIN, MY FREEDOM AFFORDED BY THE CONSTITUTION, LOSS OF HOUSING, CAUSED ISSUE WITH MY EMPLOYMENT/PAY, MY VEHICLE WAS SEARCHED WITHOUT A WARRANT UNDER THE GUISE OF IT BEING AN 'INVENTORY' OF CONTENTS BECAUSE IT WAS BEING TAKEN AWAY FROM ME AND TOWED FROM A ~~REGULAR~~ REGULARLY USED PARKING SPOT OF MINE.

I NOT ONLY USED MY OWN MONEY TO BAIL OUT OF THE LOCAL JAIL, I WAS FORCED TO 'CALL IN TO PRETRIAL SERVICES' EVERY MONDAY FOR NEARLY 9 MONTHS AS IF I WAS FOUND GUILTY OF A CRIME WITHOUT A TRIAL, AND SENTENCED TO 'PROBATION' TYPE PUNISHMENT. I WAS DETAINED & ARRESTED APRIL 24th 2025 ~~AND ST~~ WHILE ASKING OFFICER HOLMES TO JUST GO AHEAD AND WRITE ME

A TICKET THEN FOR GOING UNDER THE LIMIT. STILL, TO THIS VERY DAY I FEEL 'UNDER ARREST' MENTALLY. ITS CAUSED EMBARRASSMENT TO THIS DAY. IN FACT, I CAN STILL SEE MY PICTURE/MUGSHOT POSTED ONLINE ONE FULL YEAR AFTER THE STOP BY OFFICER HOUNES, DAVIS, STOCKTON, AND THE OTHERS OF THE KWP.D. THANK YOU FOR REAL RELEASING 'SOME' OF THE BWC & DASHCAM FOOTAGE FROM THAT NIGHT, AS WELL AS THE PERSONEL FILES I'VE REQUESTED THUS FAR. PLEASE LET ME KNOW IF YOU'D LIKE TO FURTHER DISCUSS THIS INCIDENT, THE LEGALITY OR NON-LEGAL STOP, THE DISCREPENCY & FALSITIES RECORDED IN THE WRITTEN POLICE OFFICIAL REPORT, ANY RIGHTS VIOLATIONS, ETC, AND HOW THE KWP.D WISH TO PROCEED. THANK YOU FOR READING AND ANY FURTHER DECISIONS MADE

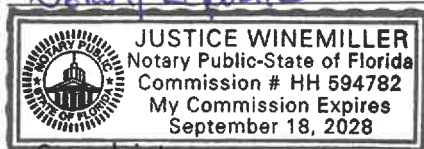

1. Whoever makes a false statement which he does not believe to be true, under oath, not in an official proceeding, in regard to any material matter shall be guilty of a misdemeanor of the first degree, punishable as provided in F.S. 775.083 or F.S. 775.085.

2. Knowledge of the materiality of the statement is not an element of this crime, and the defendant's mistaken belief that this statement was not material is not a defense.
