A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED PURSUANT TO SECTION 2-797(4)(b) AND SECTION 2-844, BRAND NAME SPECIFICATIONS OF THE CODE OF ORDINANCES THE BID OF ANIXTER, INC. IN THE AMOUNT OF \$23,196.00 FOR TWELVE (12) LED STREET LIGHTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff obtained price quotes for Beacon Products Energy-Efficient Street Lamps from three vendors and determined that Anixter, Inc. provided the lowest quote, and recommends the approval of a brand name specification purchase, pursuant to section 2-844 of the Code of Ordinances.

WHEREAS, Key West Code of Ordinances section 2-797(4)(b) further provides "If in the opinion of the city manager exceptional circumstances exist to exempt a purchase from the competitive bid requirements of this subdivision for the best interests of the city, he shall place a resolution before the city commission for approval of such exemption."; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Anixter, Inc., Inc. in the amount of \$23,196.00 is hereby awarded, pursuant to section 2-844 and section 2-797(4)(b) of the Code of Ordinances.

Section 2: That funds for this purchase are budgeted in  
FY 15/16 under account 102-4101-541-6300.

Section 3: That this Resolution shall go into effect  
immediately upon its passage and adoption and authentication by  
the signature of the Presiding Officer and the Clerk of the  
Commission.
