A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) TYMCO MODEL 600 STREET SWEEPER WITH RELATED ACCESSORIES IN AN AMOUNT NOT TO EXCEED \$498,000.00 FROM CONTAINER SYSTEMS & EQUIPMENT CO., INC., THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA23-EQU21.0, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE COMMUNITY SERVICES DEPARTMENT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contracts; and

WHEREAS, this purchase will be made under the Florida Sheriffs Association Contract No. FSA23 - EQU21.0, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of One (1) TYMCO Model 600 Street Sweeper with related accessories as described in the attached proposal of Container Systems & Equipment Co., Inc., pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association Contract No. FSA23-EQU21.0, in an amount not to exceed \$498,000.00, is hereby authorized for use by

the Community Services Department.

Section 2: That funds for the purchase of this equipment are budgeted FY25-26 in Internal Improvements/Streets/Machinery and Equipment account 102-4102-541-6400. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
