A motion was made by Commissioner Lee, seconded by Commissioner Castillo, that the Resolution be Passed with three amendments to the text. Immediately after stating the main motion, Commissioner Haskell made a motion, seconded by Commission Hoover, to postpone the Resolution until the Commission receives clarity in the South Miami action. That motion failed with Vice Mayor Carey, Commissioners Castillo, Lee, and Mayor Henriquez voting No and Commissioners Haskell and Hoover voting Yes.

The amendments to the text were then voted on individually:

1. Striking the word 'voluntary' from the title carried with Commissioners Haskell and Hoover voting No and Vice Mayor Carey, Commissioners Castillo, Lee, and Mayor Henriquez voting Yes.
2. Amending the third whereas clause to read, 'On June 30, 2025, the Key West City Commission, voted to void the existing 287(g) agreement, that had been improperly executed without the legal authority under the City Charter.' carried with Vice Mayor Carey and Commissioner Castillo voting No and Commissioners Haskell, Hoover, Lee, and Mayor Henriquez voting Yes.
3. Striking the word 'reinstating' from the last whereas clause and inserting 'entering into' failed with Vice Mayor Carey, Commissioners Castillo, Haskell, and Hoover voting No and Commissioner Lee and Mayor Henriquez voting Yes.

Then, Commissioner Haskell made a motion to add a whereas clause that states; The Commisison acted in good faith as neither the plain text of F.S. 908 nor standing judicial rulings require "Participating in any program or agreement authorized under section 287 of the Immigration and Nationality Act, 8 U.S.C. s. 1357." This motion failed for lack of a second.

The main motion, as amended, then carried by the following vote:

Yes: 4 - Vice Mayor Carey, Commissioner Castillo, Commissioner Lee and Mayor Henriquez
