A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MOTE MARINE LABORATORY TO CONDUCT A "FLORIDA KEYS OCEAN FESTIVAL" AT 38 E QUAY ROAD TRUMAN ANNEX ON SATURDAY, MARCH 29, 2014, FROM 8:00 A.M. TO 7:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE USE OF THE TRUMAN WATERFRONT NEXT TO THE ECO DISCOVERY FROM 8:00 A.M. TO 7:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECTIVE DATE

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That Mote Marine Laboratory is hereby granted permission to conduct a "Florida Keys Ocean Festival" on the days and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; provided the organization meet the terms and conditions set forth by the City Manager. That 100% will be donated to the Mote Laboratory.

SECTION 2. That Mote Marine Laboratory is hereby granted permission the use of the Truman Waterfront property next to the Eco-Discovery building at 38 E Quay Road.

SECTION 3. That the Mote Marine Laboratory will submit to the City of Key West a user fee payment of \$500.00 and a deposit of \$1,000.00 for any damage risen out of the event at the Truman Waterfront.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That Mote Marine Laboratory will adhere to the recycling plan of the City

of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
