A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(3) THE PURCHASE OF A 2024 FORD F-350 DUMP TRUCK IN AN AMOUNT NOT TO EXCEED \$67,221.00 FROM DUVAL FLEET THROUGH A COOPERATIVE PURCHASING CONTRACT (FLORIDA SHERIFF'S); AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, during the FY2021/2022 budget approval process, the City Commission authorized the purchase of a dump truck in the amount of \$40,000; and

WHEREAS, in April 2022 a quote was issued from Duval Ford, LLC, in the amount of \$49,982, leveraging a Florida Sheriff's Cooperative contract, under purchasing exception 2-797(3) of the Code of Ordinances authorizing purchases pursuant to government contract; and

WHEREAS, Ford did not produce a 2023 model of this chassis type, and City was told we would need to upgrade to model year 2024, which price was now \$67,221 upon delivery; and

WHEREAS, the department has needed the vehicle since budget season in 2021, and the vehicle is two model years newer than originally ordered,; and

WHEREAS, City staff recommends procurement of a Ford F-350 dump truck from an authorized vendor via the Florida Sheriff's Cooperative Purchasing Contract; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a Ford F-350 dump truck, in an amount not to exceed \$67,221, which includes an increase of \$17,239 over the original 2021 purchase price, from Duval Fleet is hereby approved, pursuant to Section 2-797 (3) of the Code of Ordinances.

Section 2: That funds for this purchase are budgeted in account 405-7504-575-6400 in the amount of \$49,982, and a budget transfer of \$17,239 from Key West Bight reserve account 405-7501-575-9803 is necessary.

Section 3: That the City Manager is authorized to execute any necessary documents associated with this purchase, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage, adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
