This is to request the dates of 19 - 28 April 2013, for the Conch Republic Independence Celebration.

Specific to this Celebration we would respectfully request permission from the City of Key West to conduct the annual "World's Longest Parade" on Thursday the 25th of April in accordance with time-honored tradition.

We respectfully request that Duval Street be closed at 6 PM on the aforementioned date between United and South streets for the mustering of the Parade. Additionally, this year we are requesting to close United Street between Whitehead and Simonton Streets to traffic and parking between the hours of 7 PM and 8 PM in order to muster a large marching band planning to attend this year's parade. We would be able to accommodate "local traffic" on United during this time and will not block any driveways or entrances. The parade will roll promptly at 8 PM. We will be responsible for the cost of police and public works for this event, as always.
