A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT DATED JULY 10, 2019 APPROVED BY THE CITY MANAGER AS PROVIDED FOR UNDER SECTION 2-797(2) and 2-797(4) OF THE CODE OF ORDINANCES, FOR STEWART & STEVENSON POWER PRODUCTS, LLC IN AN AMOUNT NOT TO EXCEED \$31,199.02 TO RENT A DIESEL GENERATOR FOR THE KEY WEST POLICE DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the generator at the Key West Police Station became inoperable in March 2019, and after evaluation, City staff determined that it was necessary to rent a temporary generator, while repairs were completed, or a replacement generator was obtained; and

WHEREAS, three price quotes were obtained for rental of a generator with adequate capacity to meet the needs of the KWPD, and Stewart & Stevenson provided the lowest quote; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize and procure the generator to support essential operations at the KWPD in the event of a power failure; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Declaration of Emergency for Monthly Rental of Generator for the City of Key West Police Department" dated July 10, 2019 by the City Manager, pursuant to section 2-797(2) and 2-797(4) of the Code of Ordinances, to procure a rental generator from Stewart & Stevenson Power Products, LLC in an amount not to exceed \$31,199.02 is hereby ratified.

Section 2: That this procurement will be paid from budget line General Fund/Police Department/Rental and Leases Account 001-2101-521-4400, through a transfer from the City Manager Contingency Fund, and any necessary budget transfers or adjustments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
