-- Alexander James Snider Arrest Narrative:

On Monday, February 6, 2023, at approximately 0042 hours, I (Ofc Andrade) and Ofc J. Young responded to the pier area directly behind Ocean Key Resort, 0 Duval St, reference a male masturbating in plain sight.

On arrival I witnessed an adult male (later identified as Alexander James Snider, DOB 07/04/1984) on the pier, naked from the waist down, with his penis in his hand actively masturbating. Ofc J. Young illuminated Alexander with her flashlight, and I identified myself and ordered Alexander to stop. Alexander stopped and turned to look at us then turned away and immediately began to run in the opposite direction. I ran after him ordering Alexander to stop several times. Alexander continued running away from me until I was able to grab him from his left arm and his upper back area where I then redirected his momentum to the ground. Ofc J. Young arrived, and we placed Alexander into handcuffs. Ofc Bouvier and PO Caldwell arrived on scene moments later.

Alexander said that he just wanted to get dressed and that's why he ran. I told Alexander that he could have said so when we first addressed him. PO Caldwell and I put Alexander's shorts on him. Alexander had a grey bag with him and searched it subsequent to arrest. During the search I discovered two glass pipes, commonly used to smoke marijuana. One pipe was black and purple in color and the other was multicolored. Both glass pipes contained burnt residue.

Alexander began to say that he was sorry for masturbating and that he was trying to hide from the sight of others and that is why he was on the dark pier.

PO Caldwell spoke to Ocean Key Resort private security person, David, and obtained a statement from him. In his statement David attests that he witnessed Alexander watching pornography on an electronic device while masturbating. David's statement also says that he asked Alexander to leave the property, but Alexander refused. Ofc Bouvier informed me that David would like Alexander to be trespassed from the property and wished to press charges against Alexander for this instance.

I briefly left the area to retrieve my patrol vehicle and spoke to Sgt Kouri making him aware of this response to resistance incident.

I relocated my vehicle to Ocean Key Resort covered parking area that was near Alexander's location. Ofc Bouvier walked Alexander to my patrol vehicle. I asked Alexander if he had anything in his shoes and he said no. I told Alexander to remove his shoes and he did. I then had him step towards the rear passenger side of my patrol vehicle where the door was already opened. I ordered Alexander to get in my patrol vehicle and Alexander refused, saying he wanted his shoes. I told him I would get them for him and ordered Alexander again to get in my patrol vehicle but Alexander continued to refuse. I attempted to push down on Alexander's right shoulder with my left hand while pushing on his abdomen with my right hand directing him into the backseat. Alexander stiffened his torso, became rigid, and did not move. I told Alexander that he would be tased if he did not get into my patrol vehicle. Alexander said he didn't care and again refused. I drew my TASER and arched it twice, in an effort to gain compliance, and told Alexander again he would be tased if he did not comply. Alexander began to bend at the waist and sat on the edge of the backseat closest to the door with his legs still outside the vehicle. I directed him back with my right hand on his abdomen. Alexander then made himself rigid again and began pushing his torso against my hand, towards me, in an attempt to stand up and get out of the vehicle. I then drive stunned Alexander briefly in the abdominal area in an effort to place him fully in the backseat. Once seated, Alexander forcefully kicked his right leg towards me, striking me in the chest with his right foot. I immediately stepped back and deployed my taser striking

Alexander in the abdomen, momentarily incapacitating Alexander. I used this opportunity to push Alexander backward into the backseat with my left hand while I held his legs down with my right hand. Alexander still refused to place his legs inside the vehicle and continued his efforts to exit the vehicle, now with much greater force. Ofc Bouvier drive stunned Alexander ordering him to place his legs into the vehicle. Alexander finally allowed me to place his legs into the vehicle. I removed one of the taser probes lodged in his abdomen (the other probe became dislodged during the ensuing struggle) and closed the door.

Sgt Kouri arrived on scene and evaluated Alexander`s injuries. Alexander told Sgt Kouri that was "Horny," and just need to masturbate.

I transported Alexander to Lower Keys Medical Center, 5900 College Rd, where he was medically cleared. I then transported Alexander to the Monroe County Detention Center for processing.

Alexander suffered an abrasion to his left knee as a result of me directing him to the ground. Alexander also suffered two puncture marks from the TASER probes. I photographed Alexander`s injuries. I submitted the photographs to Evidence.com via Axon Upload.

David`s Statement Form was submitted to the Key West Police Records Department. The expended TASER cartridge and the glass pipes were submitted to the Key West Property and Evidence Department by PO Caldwell.

My BWC was activated during this incident and submitted to Evidence.com.

Based on the facts and evidence, I believe there is probable cause that on February 6, 2023, Alexander James Snider did knowingly and intentionally violate F.S.S. 800.03 Lewdness and Lascivious Conduct, by actually and intentionally wearing no clothing from the waist down, and masturbating with his penis fully exposed, on the pier located on the west end of 0 Duval Street, an area open to the public.

Based on the facts and evidence, I believe there is probable cause that on February 6, 2023, Alexander James Snider did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by purposely kicking me in the chest with his right foot as I attempted to place him into the backseat of my patrol vehicle, while I was engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on February 6, 2023, Alexander James Snider did knowingly and intentionally violate F.S.S. 893.147(1) Possess and/or Use Drug Paraphernalia, by actually and intentionally possessing one black and purple glass pipe and one multicolored glass pipe consistent with narcotics use, within his possession.

Based on the facts and evidence, I believe there is probable cause that on February 6, 2023, Alexander James Snider did knowingly and intentionally violate F.S.S. 843.02 Resisting without Violence, by actually and intentionally running away from me in the opposite direction in an effort to evade me while I conducted a legal, lawful investigation, while engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that that on February 6, 2023, Alexander James Snider committed the act of trespassing, in violation of FSS 810.09(1)(a)1(b) by willfully entering and remaining on the property located at 0 Duval Street, known as Ocean Key Resort, and defying an order to leave, personally

On 2/6/2023 at 0042 hours, I responded to 0 Duval Street (Ocean Key) in response to reports of a male subject masturbating in public, while watching pornographic movies on his cell phone.

Upon arrival, Officer Andrade and I entered the boardwalk area behind Ocean Key and once we stepped onto the Pier, I immediately saw a taller white male, standing and facing the hotel, approximately 50 feet away from us. The male had an erection and was stoking his penis back and forth. It was obvious the male was masturbating out in public, where children and/or families could see, had they been somewhat in close proximity. I shined my flashlight on the male and Officer Andrade gave a loud verbal announcement, stating "Key West Police Department, Stop!" The male did not listen to commands and began running towards the Sunset Pier, with no pants on, erection in tow.

Officer Andrade and I engaged in a brief foot pursuit, Officer Andrade was about 4-5 seconds ahead of me and turned the corner to the right, behind the tiki bar. As I turned the corner behind him, I saw Officer Andrade had the male on the ground and was attempting to place him in handcuffs. I jumped in to assist and Officer Andrade and I helped to handcuff and secure the subject.

The subject began spontaneously uttering that he was just trying to finish his business. He also spontaneously uttered that security told him he probably did not want to do that there (assumably referring to his lurid self abuse) and mentioned he stayed because he thought the security guard then told him it was ok to be there. The subject also spontaneously uttered that the reason why he ran was because he wanted to put on his shorts and did not want to catch a lewd and lascivious charge.

Officer Bouvier and I escorted the male subject to Officer Andrade's car. Officer Andrade and I instructed the male to have a seat, in the back of Officer Andrade's patrol vehicle to which he did not comply. Several requests to sit down in the car were asked of the male which turned into loud verbal commands and the subject did not comply. Officer Andrade pulled out his Taser and announced to the male to stop, or he would be tased. The male did not comply. I loudly and repetitively told the male to Stop or he would be Tased and again, he did not comply. Officer Andrade gave the male a spark warning, and the male did not comply. Officer Andrade drive stunned the male in the stomach area and he retaliated by kicking at Officer Andrade. Officer Andrade then Tased the male with the probes, and the male was still being difficult and not getting fully into the car. Officer Bouvier then drive stunned the male, in the chest area. Eventually, the male complied and Officer Andrade and I finished placing him into the car, while he e stated he did not want to get into the car because he wanted his shoes.

At this point, this concludes my involvement with this case. My Axon bodycam was active during this incident and uploaded to evidence.com.

On Monday February 6, 2023, at approximately 12:30 AM, I Ofc. K. Bouvier responded to 0 Duval Street (Ocean Key Resort), in reference to a call of man masturbating by the hotel pool, refusing to leave.

Officers were instructed to approach from the Mallory Square entrance, and as I arrived, I heard Ofc. E. Andrade yell "Police Stop". A short time later I heard Ofc. J. Young air over Key West Police Communication Channel One, (Comm One), that the suspect was stopped on the pier of the hotel. I drove the patrol cart from Mallory Square to the pier where the officers and suspect were located.

Upon arrival, I saw a white male sitting up on the dock, naked from the waist down. The suspect made several spontaneous utterances stating how he was "Horney" and he thought it was ok to do what he was doing because "There wasn't anybody around".

Once the suspects pants were searched they were put back on him and he was subsequently arrested. Once at the patrol car the suspect refused to enter the patrol car. Ofc. E. Andrade instructed the subject to get in the car several times and the suspect refused to comply each time. Ofc. E. Andrade used his electronic control weapon, (ECW), to conduct a spark display as warning to the suspect. The suspect still refused to comply at which point Ofc. Andrade delivered a drive stun to the suspect. The suspect then kicked Ofc. Andrade causing his ECW to fall to the ground. I then removed my ECW from the holster and delivered a drive stun to the suspect, who then complied and entered the patrol car.

I notified Comm One and the supervisor of the ECW use.

My KWPD issued Body Cam was activated during this call.
