Diameter: 16.2"

Location: 60% (growing in front yard-very visible tree, canopy growth impacted by power lines and adjacent tree canopy.)

Species: 100% (on protected tree list)

Condition: 50% (overall condition is fair to poor, old injury on main trunk-tree is oozing a waxy liquid.)

Total Average Value = 70%

Value x Diameter = 11.3 replacement caliper inches

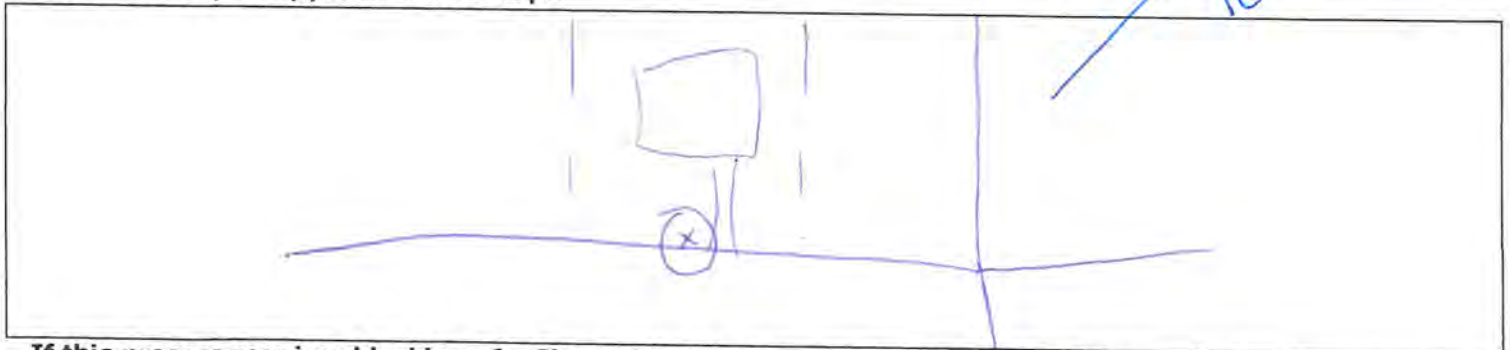
Sketch location of tree in this area including cross/corner Street

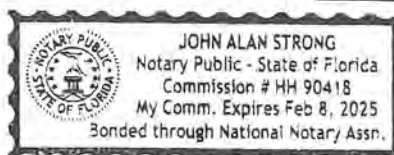
