Dear Commission Members,

I am writing you about my finding of Formosan Termite damage to the home of Robert and Camilla Goble at 1406 South Street. I have provided professional termite control service for the Goble's since 2000 and more recently since 2017 at their South Street home.

We perform annual inspections and treatment as needed at their home every April. In March this year I did a walkaround check of the house with Mr. Goble in preparation for an under house spraying update for underground Formosan termites and did not see any signs of termite damage at that time. I did notice termite mud tunnels on the Royal Poinciana tree 9' from the front center of the house and indicated to Mr. Goble that could be a damage problem source for the house. On April 19 while completing the under-house treatment we found termite tunnels on the foundation footing under the front center of the house. They were sprayed immediately.

Upon completing the inspection above ground at the front center section of the house we found active Formosan termites and substantial damage for which the Goble's have provided photographs. It is most likely that these termites came from the adjacent poinciana tree. I also knew that from Mr. Ken King's periodic trimming of the tree since 2017 that he had found termite damage progressing inside the poinciana each year.

I consequently recommended immediate removal of that tree to Mr. and Mrs. Goble.
