Any qualified engineer familiar with our aqueduct system could have advised that it was in desperate need of repair and that our ever-increasing development and growing population could not sustain our consumption. But instead of warning us of the pending crisis, the need to curtail development/usage, and getting started on replacing the pipes, the FKAA's Board of Directors chose to stay silent, build a new building with all the bells and whistles and eliminated the need to have an engineering degree to serve as Executive Director.

Mr. (Greg) Veliz, our current Executive Director, made it no secret that the only thing he knew about water management, when he took the job, was "how to turn on a tap." Maybe, instead of focusing on awarding lifetime benefits to Mr. Veliz and other upper management employees, as well as their spouses, for their "lifetime dedication to FKAA" they should focus on answering a few simple questions like: How long will we be at 22 million gallons a day? ("Indefinitely" is not an answer). What impact does the multitude of new swimming pools and irrigation systems for vacation rentals and remodels/renovations have on usage? Will the new pipes increase the amount of gallons per day, or will we be in an endless catch-up scenario of patching broken pipes?

Perhaps, at the very least, a "prioritized building moratorium" should be considered by the county, until such time as we have answers to these and other fundamental questions.

It is your prerogative and choice to pursue my removal via Code Section 90-52 by a majority vote of the City Commission and I would be in attendance to defend my letter and my position.

The last paragraph of my letter to the editor, from which you apparently take exception to, is merely a suggestion to the county and the county alone, that "perhaps" they should "consider" a "prioritized building moratorium" and only until vital questions concerning the water crisis are answered. A critical concern shared up and down the Keys and on every social media platform including the Citizen Voice. Given the number of signs with requests by the FKAA that we conserve water, statements that future water main breaks are pretty much a given and that they have reduced water pressure, asking questions is not uncalled for. The main difference, is I won't sit behind an anonymous post.

I sit on a diverse Planning Board with six other members all of which have very strong and sometimes very vocal opinions about a wide range of potentially relevant topics that could come before the Board, but rest assured with 25 years as a trial attorney, in a Quazi Judicial forum, I will not substitute my opinion for the rule of law, codes and the criteria as placed before me and all of my votes are based on the criteria laid out in the codes, as my voting record since 2016 should show.

I have enjoyed serving on the Planning Board over the last seven years, and as a review of the Board minutes will demonstrate have made a real difference when it

comes to moving affordable housing forward from College Road, to Trumbo, to the 3.2 Lofts in Bahama Village. I have championed this cause at every available opportunity. I have lead the charge against the expansion of transient rentals. I have stood before our commission, when Craig Cates was mayor, and secured an unanimous vote against rezoning Clinton Square thereby preventing it into becoming another lower Duval. I made a commitment to serve this community until at least July of 2025---and I keep my commitments, so once again I will not be "stepping down" so if you want me removed you will have to pursue the Section 90-52 and I will gladly plead my case in front of the commission and the residents of Key West.

It should be noted that over the years, I have even arranged my travel schedule so that I do not miss a meeting.




