**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING CHEF DISTILLED, LLC. TO CONDUCT THE SOUTHERNMOST BUOY 40<sup>TH</sup> BIRTHDAY CELEBRATION ON SUNDAY, SEPTEMBER 10, 2023, FROM 4:00 P.M. TO 9:00 P.M. (SET UP STARTING AT 10:00 A.M.) AT THE TRUMAN WATERFRONT GREEN FIELDS BY THE SPASH PAD; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** Chef’ Distilled, LLC wishes to conduct a Southernmost Buoy 40<sup>th</sup> Birthday Celebration on Sunday, September 10, 2023, from 4:00 p.m. to 9:00 p.m.; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida.

**SECTION 1.** That in Resolution 19-174, the City Commission directed the city. Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law.”

**SECTION 2.** “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “To go” packages for food or products sold on any property leased from the City.”

**SECTION 3.** That Chef Distilled, LLC is hereby granted permission to conduct the Southernmost Buoy 40<sup>TH</sup> Birthday Celebration on the day and during the hours stated above, PROVIDED that all trash is collected and contained; that a guarantee indemnifying the city is executed; that the organization meets the terms and conditions set forth by the City Manager.

**SECTION 4.** That Chef Distilled, LLC is hereby granted permission for the use of the Truman Waterfront Green Fields by the Splash Pad.

**SECTION 5.** That Chef Distilled, LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That pursuant to Section 18-86 of the Code of Ordinances, Chef Distilled, LLC. Is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 7.** That Chef Distilled, LLC. Must post the required notice regarding prohibition of purchase and consumption of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least ten (10) days in advance.

**SECTION 8.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
