A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING TASK ORDER NO. 1-16-SWR FROM CH2M HILL ENGINEERING, INC. IN AN AMOUNT NOT TO EXCEED \$227,638.00 FOR DESIGN, PERMITTING AND BID PHASE SERVICES FOR THE REHABILITATION OF PUMP STATIONS "H" AND "B"; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 12-280, the City Commission approved a contract with CH2M Hill, Inc. for General Engineering Services and in Resolution 15-208 the contract was renewed for a two-year term; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Task Order No. 1-16-SWR for CH2M Hill Engineering, Inc. for design, permitting and bid phase services for the Rehabilitation of Pump Stations "H" and "B" is hereby approved in an amount not to exceed \$227,638.00.

Section 2: That funds for the lift station rehabilitation project are budgeted in FY 2016/17.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
