A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING THE ADDENDUM EXTENDING THE CITY'S AGREEMENT WITH ARNOLD'S AUTO AND MARINE REPAIR, INC. TO PROVIDE TOWING AND STORAGE SERVICES EXTENDING THE AGREEMENT FOR AN ADDITIONAL TWO (2) YEARS BEGINNING JULY 1, 2025 - JULY 1, 2027; AUTHORIZING THE CITY MANAGER TO EXECUTE THE ADDENDUM, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, On June 16, 2021, the City Commission approved Resolution No. 21-124 awarding RFP #004-21 to Arnold's Auto & Marine Repair, Inc. to provide towing services for non-consensual tows and tows initiated by law enforcement for the City of Key West, Florida; and

WHEREAS, the current Agreement is set to terminate on July 1, 2025, and pursuant to Section 1 of the Agreement, both parties desire to extend the Agreement for an additional two (2) years, commencing July 1st, 2025 and terminating on July 1, 2027 ; and

WHEREAS, in 2021, Arnold's Auto & Marine Repair, Inc. proposed paying the City \$90.00 per \$135.00 tow, which would equate to \$158,310.00 paid to the city for towing 1,759 vehicles at the lowest level of service; and WHEREAS, any adjustments to the rate schedules for towing and storage services will be updated by amendment to the Code of Ordinances, City of Key West upon approval of an amending Ordinance by the City Commission; and

WHEREAS, staff recommends the City Commission approve the Addendum extending the Agreement with Arnold's Auto and Marine Repair, Inc. for an additional two (2) years beginning July 1, 2025 and terminating July 1, 2027;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

<u>Section 1.</u> That the Commission approves the Addendum extending the City's Agreement with Arnold's Auto and Marine Repair, Inc. for towing and storage services for the City of Key West, Florida for an additional two-year term beginning July 1, 2025 and terminating July 1, 2027.

<u>Section 2.</u> That adjustments to the rate schedules for towing and storage services will be updated by amendment to the Code of Ordinances upon approval of an amending Ordinance by the City Commission.

<u>Section 3.</u> That the Commission hereby authorizes the City Manager to execute the Addendum and any necessary documents, upon consent of the City Attorney. <u>Section 4.</u> That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
