A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT TO FLORIDA KEYS MEDIA FOR THE PET MASQUERADE AT THE TRUMAN WATERFRONT COFFEE BUTLER AMPHITHEATER ON WEDNESDAY, OCTOBER 21, 2026, FROM 5:00 P.M. TO 9:00 P.M. (SETUP AT 10:00 A.M.); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Florida Keys Media has applied to the City for a Special Event Permit for their event "Pet Masquerade" to take place on Wednesday, October 21, 2026, from 5:00 p.m. to 9:00 p.m. (Setup at 10:00 a.m.), at the Truman Waterfront Coffee Butler Amphitheater.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida.

SECTION 1. That In Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of goods or services, unless such use is otherwise preempted by law."

SECTION 2. That vendor/lessee/licensee/contractor acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor

therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City.

SECTION 3. That Florida Keys Media is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place as herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the City is executed; and that organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Florida Keys Media is hereby granted permission for the use of the Truman Waterfront Coffee Butler Amphitheater.

SECTION 5. That pursuant to Section 18-86 of the Key West Code of Ordinances, Florida Keys Media is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 6. That Florida Keys Media must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 7. That Florida Keys Media will adhere to the recycling plan of the City of Key West, and that one (1) recycling container for every one (1) trash barrel will be used and that they

will be placed side by side.

SECTION 8. That Florida Keys Media acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
