Please be advised that I object in the strongest terms to the proposed major development located directly across the street from Grace Lutheran Church and School. A single-family residential area across from a childcare facility and elementary school is no place to build a massive, low-rent, high-density apartment complex.

I write to you personally because Grace Lutheran was noticed too late to have the subject addressed by our board of directors. However as a lifelong member of the church, and having served many times as congregational president and chairman of our school board, I feel qualified to assess the impacts on our school.

What was once St. Bede's Catholic Church has developed into a ten unit, low rent (no rent?) apartment building, and an onsite facility for feeding the homeless. Certainly feeding the homeless is a fine Christian mission, and the charitable work done by the Catholic Church is to be much admired. It is only the location that is objectionable.

For over sixty years Grace Lutheran School has provided elementary education, as well as preschool and infant care for thousands of Key West families. Since the opening of the Catholic charitable facility, our school and church has had a continuous problem with homeless intruders.

Presumably the Key West Police Department files a report every time they are called to remove a belligerent or incapacitated person from the school premises. If so, you will see a file with scores of reports. Additionally, we have had hundreds of incidents involving the homeless, which we have been forced to deal with internally.

I have personally been called away from my place of business multiple times to deal with homeless problems. We have found them sleeping on the children's playground, in the walkways, bushes, and parking lot. They have as well, vandalized our church and school, frightened teachers, parents, and children, and committed numerous unmentionable offenses. I feel certain the Catholic Church is proceeding with the best of intentions. However, just as St. Bede's evolved into the situation we now have, a high density, low-rent development in this location is certain to be a continuing source of problems for all neighbors, and especially for our school.

I urge you to reject this request. It is a huge leap from single family residential to major development use, and being directly across the street from a long established grade school and childcare center seems reason enough for denial.

Thank you for your consideration in this matter.

Dear Board Members and Staff of the City of Key West Planning Board:

We have recently received a Notice from the City (on Thursday January 14<sup>th</sup>) regarding the proposed development at 2700-2706 Flagler Avenue (RE# 00065090-000000, AK # 1065617). The information packet mentioned in the Notice is not available online as of this time. The only information we have regarding the project is the following correspondence from the program director:

## Definition:

Saint Bede's Village Supported Community Housing for residents of Key West will add twenty-nine units of single room occupancy apartments to the existing ten on the property. The additional 29 units will be made available to residents of Key West in the workforce who are experiencing persistent housing instability. This service-enhanced housing and community living is provided in a safe environment that encourages maximum independence for persons who do not require 24-hour care.

## Goal:

To provide a therapeutic housing environment which helps residents maintain stable residency, reduce homelessness, develop personal support systems and achieve other positive life outcomes.

We certainly have not had enough time to fully research or have an official meeting and consensus regarding the potential effects this project will have on our childcare facility, preschool, elementary and middle school. But we currently serve approximately 100 children from the ages of 6 weeks old to 8<sup>th</sup> grade. Our experience with the current use of the property has been a major burden on our day to day operations. In addition to the current housing, St. Mary's Soup Kitchen which operates out of the subject property has attracted hundreds of people during the week and there have been so many incidents of trespassing and other violations over the years that we can't even count. We have been informed by Police that we have to keep the unsightly and unwelcoming "No Trespassing" signs all over our premises. Then we are to call the police every time someone comes on to the property. This is very unnerving for the staff and the students to deal with on a regular basis.

While we are extremely compassionate and concerned about problems of homelessness, we also provide a vital service to the families in this community, and our primary duty and obligation to the students, parents, and staff of our school is to maintain a safe environment. Having more housing units than is currently allowed in a single family zoning will only exacerbate the problem, creating a situation where more people are congregating in a condensed area. Although we do not know the criteria set for future residents of this project, our experience with trespassing over the years seems to show that there are many cases of mentally unstable individuals that tend to gravitate around this property. The potential of having any more incidents on our property than there currently are is a very large concern for us.

We appreciate your consideration in this matter.

Dear City of Key West:

Thank you for making me aware of a proposed development at 2700-2706 Flagler Avenue (RE# 00065090-000000, AK # 1065617) and providing me the opportunity to voice my concern. While I am a church member at Grace Lutheran Church and board member on the Grace Lutheran School Board, I am writing today as a parent of two little girls who attend Grace Lutheran School. I know that homelessness is a major concern in our community and I believe we should do what we can as individuals and as a community to help this population. I do not believe, however, that this service should come at the expense of the safety of our children.

Out of the 95 registered sex offenders located within 5 miles of 2700 Flagler Avenue, 34 of them have a reported address of transient or temporary (documentation enclosed). According to the U.S. Department of Housing and Urban Development, mental illness amongst the homeless population is approximately 25% (2015). And although obtaining an accurate, recent count is difficult, the Substance Abuse and Mental Health Services Administration estimates, 38% of homeless people were dependent on alcohol and 26% abused other drugs (National Coalition for the Homeless, 2009). Knowing these statistics makes locating what is basically a homeless community center across the street from a school reckless and irresponsible. Not only would the center be across the street from children, but the bike path and bridge, which would be used regularly by residents and visitors of the center, is right behind the school playground. This area is more secluded and less patrolled than Flagler Avenue, posing an even greater risk to our children.

I sincerely hope we are able to create a center to service the homeless population in an appropriate location. 2700-2706 Flagler Avenue is NOT the appropriate place for this facility. Please do not approve land use for this purpose.
