A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) 2021 FORD ESCAPE (\$20,981.00), ONE (1) 2022 FORD F-250 (\$35,293.00), ONE (1) 2022 FORD F-250 EXTENDED CAB (\$31,366.00), AND ONE 2022 FORD F350 WITH 3,000 LB AUTO CRANE (\$54,418.00) IN A TOTAL AMOUNT NOT TO EXCEED \$142,058.00 FROM DUVAL FORD FLEET SALES, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA20-VEH18.0/FSA20-VEL28.0 CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE UTILITIES DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the purchase of vehicles was withdrawn from approval by the City Commission in FY 19-20 due to the COVID-19 pandemic. This resolution presents for approval an updated purchase of necessary vehicles, which includes adjusted pricing for 2021-2022, along with necessary budget transfers and adjustments for FY 21; and

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA20-VEL28.0, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of One (1) 2021 Ford Escape (\$20,981.00), One (1) 2022 Ford F-250 (\$35,293.00), One (1) 2022 Ford F-250 Extended Cab (\$31,366.00), and One (1) 2022 Ford F350 with 3,000 Lb. Auto Crane (\$54,418.00), as described in the attached proposal of Duval Ford Fleet Sales, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties Bid No. FSA20-VEL28.0 Contract, in a total amount not to exceed \$142,058.00, is hereby authorized for use by the Utilities Department.

Section 2: That budget transfers totaling \$142,058.00 from Utilities/Sewer/Reserves 401-3501-535-9900 to Utilities/Sewer/Collections/Machinery & Equipment 401-3503-535-6400 for the purchase of the Ford Escape, Ford F250 and Ford F250 Extended Cab in the amount of \$87,640.00, and to Utilities/Sewer/WWTP/Machinery & Equipment 401-3504-535-6400 in the amount of \$54,418.00 for purchase of the Ford F350 with 3,000 lb auto crane is hereby approved to fully fund these purchases.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
