THAT the undersigned, Barbara Turner and Robert Turner, ~~individually and as husband and wife~~, being of lawful age, for the sole consideration of **Thirty Four Thousand Dollars and 00/100 (\$34,000.00)** to the undersigned in hand paid, receipt whereof is hereby acknowledged, WE, Barbara Turner and Robert Turner, do hereby and for my/our/its heirs, executors, administrators, successors and assigns releases, acquit and forever discharge **City of Key West and its direct employees, their agents, servants, successors, heirs, executors, administrators, past, present and future from any and all claims, actions, causes of action, suits, debts, dues, demands, rights, damages, Medicare Liens, MSA's, costs, loss of service, loss of consortium, expenses and compensation whatsoever, known or unknown**, which the undersigned has/have, ever had, now have or which my personal representative, my successors, my heirs or my assigns, hereafter can, shall or may have in the future, against each other and all of the foregoing discussed individuals and entities, on account of or in any way growing out of any and all known and unknown, foreseen and unforeseen bodily and personal injuries and the consequences thereof resulting or to result from an incident, casualty or event which occurred on or about the **10th day of June, 2013 at or near South Street, Key West, FL.**

To procure payment of the said sum, I hereby declare that I am more than 18 years of age; that no representations about the nature and extent of said damages made by any attorney or agent of any party hereby released, nor any representations regarding the nature and extent of legal liability or financial responsibility of any of the parties hereby released, have induced me to make this settlement; that in determining said sum I have ~~taken into consideration the damages, so that consequences not now~~ anticipated, which may result from the said incident are accepted and part of this General Release.

I hereby agree that, as a further consideration and inducement for this General Release, this General Release shall apply to all unknown and unanticipated personal injury and/or disability, and damages resulting from said incident, casualty or event, as well as to those now disclosed.

I understand that the parties hereby released admit no liability of any sort by reason of said incident and that said payment and release in compromise is made to terminate further controversy respecting all personal injury, disability, and damages that I have heretofore asserted or that I or my personal representatives might hereafter assert because of said incident. Additionally, this General Release specifically denies liability therefore and is intended to merely avoid litigation.

This General Release covers any and all claims of the undersigned ~~for pain and suffering, past, present and future, hospital, medical expenses, and any and all other claims including property damage which is the subject matter of an incident which alleged to have occurred on June 10, 2013, at or near South Street, Key West, FL.~~

This General Release shall further cover any and all claims arising out of said incident including, but not limited to, funeral expenses, medical bills, medication, hospital expenses, ~~past, present and future, hospital and doctors' liens, insurance liens, workers' compensation liens, attorneys' fees or liens, costs, and any and all other insurer's.~~

The undersigned further declare(s) and represent(s) that no promise, inducement or agreement not herein expressed has been made to the undersigned, and that this Release contains the entire agreement... between the parties hereto, and that the terms of this Release are contractual and not a mere recital.
