A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE "PUBLIC TRANSPORTATION ATTACHED AGREEMENT" (PTGA) BETWEEN DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR SFY2026 FTA SECTION 5339 RURAL BUS AND BUS FACILITY CAPITAL FUNDS IN AMOUNT NOT TO EXCEED \$228,000.00; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 25-138, the City Commission authorized certain City staff to apply for grant funding and to execute and submit grant documentation through the Federal Transit Administration (FTA) and Florida Department of Transportation (FDOT); and

WHEREAS, funding through the FDOT Section 5339 Rural Bus and Bus Facility Capital funds, provides Capital assistance for the purchase of support equipment for buses and transit facility; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Grant Agreement" (FM #452576-1-94-25) is hereby approved, between FDOT and the City, for Section 5339 Rural Bus and Bus Facility Capital funds to purchase support equipment for buses and transit facility in an amount not to exceed to \$228,000.00.

Section 2: That the City Manager is authorized to approve and execute the grant agreement, upon advice and consent of the City Attorney.

Section 3: That the City Manager is authorized to approve and execute subsequent amendments to this Agreement which may modify the project scope and period of performance, upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
