A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ACCEPTANCE OF A NON-BINDING GRANT AWARD FROM THE NATIONAL FITNESS CAMPAIGN IN THE AMOUNT OF \$35,000.00 TO SUPPORT THE INSTALLATION OF AN OUTDOOR FITNESS COURT® AT BAYVIEW PARK; AUTHORIZING CITY STAFF TO INITIATE PROJECT PLANNING, INCLUDING IDENTIFICATION OF MATCHING FUNDS AND COORDINATION WITH NATIONAL FITNESS CAMPAIGN REPRESENTATIVES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Key West is committed to promoting health, wellness, and equitable access to fitness resources for its residents; and

WHEREAS, the National Fitness Campaign ("NFC") is a nationwide initiative that supports communities in installing outdoor Fitness Courts® to provide free and accessible fitness opportunities; and

WHEREAS, the City of Key West submitted an application to NFC in September 2025, and following a competitive process, has been selected as a 2026 NFC Grant Awardee; and

WHEREAS, the City has been awarded a non-binding grant award of Thirty-Five Thousand Dollars (\$35,000.00) from NFC for the installation of a Fitness Court® as part of the Bayview Park Renovation Project; and

WHEREAS, the Bayview Park Renovation Project is part of the City's Capital Improvement Program, Project Number IS72012001 and Account Number 1017201-572-6300; and

WHEREAS, City staff also intends to apply for additional funding through the Florida Recreation Development Assistance Program (FRDAP) to support this project;

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

SECTION 1: That the City Commission hereby authorizes acceptance of the non-binding National Fitness Campaign grant award of \$35,000.00 for the Bayview Park Renovation Project.

SECTION 2: That the City Manager is authorized to initiate the project planning phase, including identifying matching funds and coordinating with National Fitness Campaign representatives.

SECTION 3: This Resolution shall become effective immediately upon adoption.
